Cavite Monthly Arbor Day: Tree Planting Activity at Taal Volcano Protected Landscape

Cebu City seizes 27 STL booths w/out permits

CALAX GOVERNOR'S DRIVE INTERCHANGE REACHES 25% COMPLETION, TO OPEN BY Q1 2025

MPCALA Holdings Inc., the concessionaire of the Cavite-Laguna Expressway (CALAX), announced that the CALAX Governor's Drive Interchange has reached its 25% completion milestone. The interchange, slated to open by the first quarter of 2025, is expected to decongest traffic on major roads in Cavite, specifically Aguinaldo Highway in Silang, and help spur economic activities for the cities and municipalities along the alignment in the province of Cavite.

Spanning 7.8 km from the Silang (Aguinaldo) Interchange to Governor's Drive, this segment will be the longest operational section of CALAX by the first quarter of 2025, while the two remaining segments are still under construction. Currently, ongoing work includes excavation works, bridge and drainage construction, and installation of fences.

Raul Ignacio, President and General Manager of MPCALA Holdings Inc., acknowledged construction challenges by the recent typhoons but affirmed the company's commitment to deliver this vital segment within schedule.

"Despite the challenges faced in construction brought about by the recent typhoons, we are pressing forward to ensure the timely delivery of the Governor's Drive Interchange. Once operational, this vital infrastructure will ease traffic congestion, provide a faster route for thousands of motorists, and stimulate economic growth across Cavite and CALABARZON." 144 tons smuggled veggies seized at Subic Port

Agricultural smugglers continue its illegal activities despite intensified campaign by the Department of Agriculture (DA) and the Bureau of Customs (BOC).

This as P21 million worth of undocumented fresh carrots and yellow onions were seized at the Port of Subic. Inside five container vans, the shipment were on board SITC Licheng vessel which arrived from China and imported by Betron Consumer Goods Trading.

Import regulations mandate that fresh vegetables and

other Agricultural food products require Sanitary and Phytosanitary Import Clearances (SPSIC) issued by the Bureau of Plant Industry (BPI).

While for processed food items, like declared commodity, frozen fish egg balls, importers are required to secure permits from the Food and Drug Administration (FDA).

During the inspection conducted by the BPI, BOC and Plant Quarantine Service, the shipment yielded 56 metr...

5k households to have water supply in upland Brgys in Cebu City

The Metropolitan Cebu Water District (MCWD) announced on 3 September 2024 to supplying water for 5,000 households in the upland barangays in Cebu City.

The groundbreaking was led by Cebu City acting Mayor Raymond Alvin Garcia and MCWD chairman Atty Jose Daluz III in Barangays Guba and Agsungot.

Garcia was happy that mountain residents will now have access to MCWD water after a long time.

"Their excavation permit is very important since it allows them to dig underground and lay down their pipes," the acting mayor said.

"We'll wait 200 days is what they said. So the next time

we go back there, it will be a ceremony of making the water flow," Garcia added.

The contractor promised that within 200 calendar days, the project will be completed.

Daluz for his part said that the water supply will come from Lusaran Bulk Water project operated by J.E. Hydro and Bio-Energy Corporation.

"For 50 years of planning on how to provide water to the mountain areas, finally, it has come today," Daluz said.

He disclosed that there will be more groundbreaking ceremonies in Cebu City's other mountain Barangays, namely: Budlaan, Pulangbato, Cambinocot, Binaliw, Pit-os, and Mabini.

Guba Barangay Captain Orlan Herrera told reporters that a steady supply of water is very important to the village with having a hospital, church and a college.

Herrera said around 1,800 households with benefit from the MCWD project.

For Agsungot Barangay Captain Pedro Damaolao, it was a dream come true.

"I have lived in Agsungot for 38 years with no clean drinking water. Our water here is so cloudy and it would take us several days to make it clear," Damaolao said.

Cebu City seizes 27 STL booths w/out permits

The Business Permit and Licensing Office (BPLO) and the Prevention, Restoration, Order, Beautification, and Enhancement (PROBE) team in Cebu City started its seizure operations on 6 September 2024, twenty-seven accredited small town lottery (STL) booths without business permits.

The operation was headed by BPLO head Terrence Saavedra and PROBE South head Kevin Sanchez.

Sanchez told reporters that the STL booths may be

accredited by the Philippine Charity Sweepstakes Office (PCSO), but the operators do not have the required permits from the local government unit.

This despite being notified by the BPLO to secure business permits but they were non-compliant.

"For now stop operations pa sila and we would like to inform them to pay heed so as not to add to their problem," Sanchez said.

This as both BPLO and PROBE will continue to seize

STL booths until their operators obtain the necessary documentation.

The BPLO is giving the operators to settle the issue as soon as possible.

The 27 seized STL booths were located in Barangays Sto. Nino, Ermita, Lorega, Zapatera, Kamputhaw, Kamagayan and Parian.

Cebu City eyes hike on BHW honorarium

Cebu City Health officials on 9 September 2024 proposed to increase the monthly honorarium of Barangay health workers (BHWs) from P7,500 to P10,000 monthly.

Altea Racuya-Lim, BHW coordinator for the Cebu City Health Department (CCHD) emphasized the need to increase

as BHWs have 24/7 work nature. There are more than 900 BHWs across the city's 80 Barangays. However, Cebu City acting Mayor Raymond Alvin Garcia expressed concerns about the city's financial capacity to the proposed increase.

"But he cannot approve the proposal just as yet because

the City's finances cannot cover the increase. For sure, other Barangay personnel like tanods, loaders, and drivers will also ask for a raise if the BHWs get one," Lim said.

CCHD Field Program head Dr. Magnolia Ngujo, highlighted the expanded role of BHWs under the Universal Health Care Act, which includes providing preventive medicine service...

Anti-graft posturing ni Mayor Vico Sotto hanggang salita lang, ayon sa Tayo Pasig Movement

Magtatapos na ang dalawang termino ni Mayor Vico Sotto sa non-stop na pagbatikos sa sinasabi nyang mga korap at tiwaling namumuno noon sa lungsod, pero hanggang sa ngayon ay wala pa umano itong naipakukulung, o pormal na nasampahan ng kaso sa Ombudsman o sa alinmang sangay ng hukuman.

Pahayag ito ng bagong tatag na 'Tayo Pasigueno

Movement,' isang sectoral org para sa tapat na serbisyo, bilang pagsusog at suportang reaksiyon sa panawagan sa social media ng mga residente na kailangang "ipakita ng punong-lungsod ang mga sinasabi nyang pagbabago hindi sa salita kundi sa gawa."

Sa Facebook page na Taga Pasig Kami ay hinikayat si Sotto na basahin ang 'open letter' na madamdaming nagpapaalala sa alkalde na kailangan na nitong mag-move on, at ihinto na ang mga paninira sa nagdaang administrasyon.

"Bukambibig nyo lagi na corrupt ang mga nagdaang administrasyon, pero ni isa ay wala kang kinasuhan at napakulong, nang ihalal kang councilor ng Pasig ay hindi naming narinig ang boses mo para ipagtanggol kami sa mga sinasabi mong Corrupt. Tikom ang bibig mo. Noong 2019 ay saka ka lang nag-ingay nang tatakbo kang mayor at siniraan mo lahat na nagdaang mayor, wala kang pinuri ni isa na akala mo ay ikaw lang ang magaling at ang aming pag-asa," saad ni Jenifer De Leon sa kanyang open letter sa Facebook kay Sotto.

Ang mga kasong binanggit sa open letter ni De Leon, na binatikos din ng Netizens, ay ang mga naisampa ng asunto sa Ombudsman laban kay Sotto na umano'y maanomalyang pagbigay ng 100 percent na discount sa bayaring multa sa isang telco at ang umano'y P17.2 milyong iskandalo sa pamimigay ng 452nd Anniversary t-shirts sa halip na P1,500 cash allowance bawat isa sa mahigit 11,000 na kawani ng LGU.

Maging ang kontrobersiyal na P9.6 bilyong City Hall complex ay ipinaalala rin sa open letter na keya magarbang proyektong na pinundohan mula sa buwis ng Pasiguenos ay dapat ang mga higit na pangangailangan ng nakararaming residente, lalo na ng maralitang sektor, ang naunang inasikaso ng LGU tulad ng ospital at mga health centers na kompleto sa gamot at mga medical instruments.

Sang-ayon naman at sumusuporta ang 'Tayo Pasigueno' sa ipinahayag na hinaing ng nitezens sa pagsabing "kailangang ihinto ni Sotto ang pagtago ng kanyang mga pagkukulang at maling desisyon sa pamamagitan ng pagturo sa umano'y mga katiwalian ng nagdaang namumuno sa lungsod na kailanman ay wala pa siyang naipakulong o nasampahan man lang ng kaso.

Talaga naman nakakabilib ang Bureau of Customs dahil sa magandang ginagawa nila.

Kahanga-hanga ang pamumuno ni Comm. Rubio kasama ang kanyang mga Deputy Commissioners, Assistant Commissioner, Directors, mga District collectors at iba pa dahil hindi lang sila magaling sa pagkolekta ng buwis para gobyerno pati na din sa mga walang tigil nilang paghuli sa mga illegal goods.

Port Nitong nakaraang linggo at sunod-sunod na naman ang kanilang huli sa mga smuggled goods. Sa Port of Subic kamakailan lang ay naharang nila ang mga ilegal na shipment ng mga produktong pang-agrikultura at sigarilyo, na nagkakahalaga ng humigit-kumulang PHP 136.59 milyon.

Ayon sa report ay noong Agosto 15, 2024, limang 40-foot container ang sinasabing naglalaman ng 13,250 na karton ng frozen fish egg balls, na may tinatayang halagang PHP 21 milyon. Gayunpaman, ang kargamento ay ginawang subject of a verification request sa pag-verify mula kay Intelligence Group Deputy Commissioner Juvymax R. Uy, at humantong sa pagpapalabas ng Alert Order laban ditto noong Agosto 22, 2024.

Sa kanilang pisikal na pagsusuri nito noong Agosto 28, 2024, natuklasan ng mga opisyal ng Customs na ang mga containers ay talagang naglalaman ng mga fresh carrots, yellow onions sa halip na mga frozen fish egg balls. Gayundin, ang kargamento ay kulang sa kinakailangang dokumentasyon, kabilang ang kinakailangang Sertipiko ng Pagpaparehistro ng Produkto mula sa FDA, isang Sanitary at Phytosanitary Certificate, at tamang deklarasyon ng aktwal na nilalaman, na lumalabag sa maramihang mga hakbang sa regulasyon tulad ng DOH FDA Administrative Order No. 2020-0017, Department ng Agriculture Circular No. 4, Series of 2016, at Republic Act No. 10863, o ang Customs Modernization and Tariff Act (CMTA), particular ang Seksyon 1400 at 1113 (f). Ang mga Warrant of Seizure and Detention ay agarang inilabas laban sa subject shipment at ang mga paglilitis sa forfeiture ay nagpapatuloy.

Bukod pa rito, noong Setyembre 6, 2024, 1,986 master case ng sigarilyo mula sa Taiwan, na nagkakahalaga ng humigit-

kumulang PHP 115.5 milyon, angnatuklasansadalawang 40-foot container. Angkargamento ay maling inilarawan bilang naglalaman ng "Packages Tissue" (mga gamit sa bahay). Ang maling representasyong ito ay lumabag sa ilang regulasyon, kabilang ang Circular No. 03 ng National Tobacco Administration ng 2004 at Bureau of Internal Revenue Circular No. 79-2022, na nauugnay sa Seksyon 1113 (f) ng Customs Modernization and Tariff Act (CMTA).

Kasamasa mga nag inspection ay sina Deputy Commissioner Uy, Port of Subic District Collector Atty. Ricardo U. Morales II, CESE, Department of Agriculture Secretary Francisco Tiu Laurel Jr., at iba pang opisyal ay nagsagawa ng muling inspeksyon sa mga naharang na produktong agrikultura.

Ayon kay District Collector Morales ang pangako ng daungan sa pagpapatupad ng mga regulasyon sa pag-import, na nagsasaad, "We are determined to prevent misdeclared and smuggled goods from entering the country. Our stringent inspection protocols ensure compliance with the law, and we will take necessary action against violators."

Mahusay talaga ang mga taga Port of Subic kaya naman sila ay patuloy na nagbabantay sa pagtataguyod ng mga regulasyon sa pag-import at pagprotekta sa kalusugan ng publiko, alinsunod sa 5-Point Priority Program ni Commissioner Bienvenido Y. Rubio. Keep up the good work subic Port! Congrats po sa inyong lahat!

Samantala, ang mga tauhan ng Bureau of Customs ay nagsagawa ng malaking enforcement operation noong Setyembre 5, 2024, sa isang bodega sa Parañaque City, at natuklasan ang PHP85 milyong halaga ng mga produktong karne at pagkain na may mga dayuhang marka.

Isinagawa ang operasyon kasunod ng pagpapalabas ng Letter of Authority (LOA) at pakikipagtulungan ng Customs Intelligence and Investigation Service – Manila International Container Port (CIIS-MICP), Enforcement and Security Service – MICP (ESS-MICP), Philippine Coast Guard-Task Force Aduana (PCG-TFA), at ang Department of Agriculture – Inspectorate and Enforcement (DA-IE).

Sa pagharap ng LOA sa kinatawan ng warehouse, nagsagawa ng masusing inspeksyon ang mga awtoridad, na natuklasan ang malaking dami ng mga produktong frozen na pagkain, kabilang ang karne ng pato, manok, at baboy, kasama ang iba't ibang mga pagkain na minarkahan sa Chinese at iba pang mga wikang banyaga. Ang kabuuang tinatayang halaga ng mga kalakal na ito ay PHP85 milyon.

Para ma-secure ang mga item, naglagay ang team ng mga pansamantalang padlock at seal sa bodega. Magsasagawa ang Customs Examiners ng isang detalyadong imbentaryo ng mga kalakal sa presensya ng mga ahente at kinatawan ng CIIS at ESS mula sa bodega. Kudos sa inyong lahat!

May isa ulit na accomplishment ang Bureau of Customs dahil noong nakaraang linggo din ay Matagumpay na nasamsam nila ang iba't ibang kalakal na nagkakahalaga ng PHP4.8 bilyon sa isinagawang operasyon sa Binondo, Maynila, noong Setyembre 6, 2024.

Dahil sabi sa hawak nilang Letter of Authority nainiharap sa administrator ng building, nag-inspeksyon ang mga operatiba ng BOC sa mga storage area at warehouse na matatagpuan sa ika-3 hanggang ika-12 palapag ng gusali.

Ang kanilang inspeksyon ay nagsiwalat ng magkakaibang hanay ng mga produkto, kabilang ang mga disposable vape at accessories, high-end na branded na damit, at mga bag mula sa mga luxury label gaya ng Gucci, Louis Vuitton, Dior, Adidas, Nike, at NBA. Natuklasan din ng team ang mga aerosols, mga school supplies na may temang karakter na nagtatampok ng mga disenyo mula sa Hello Kitty, Spider-Man, at Disney, pati narin ang iba't ibang tool, cosmetics, at pangkalahatang paninda.

In addition to the Governor's Drive Interchange, two other major segments of CALAX, Subsection 2 (Open Canal Interchange) and Subsection 1 (Kawit Interchange), are progressing steadily, with 15% and 25% completion, respectively. Both segments are expected to open by the third quarter of 2025 and will eventually connect CALAX to the Manila-Cavite Expressway (CAVITEX) via the CAVITEX-CALAX Link. Currently, the overall completion rate of the entire CALAX project stands at 64%.

At present, CALAX serves over 45,000 motorists daily. Once the full expressway is connected to CAVITEX, it will serve at least 95,000 motorists daily, significantly improving traffic flow and accessibility between Cavite, Laguna, and the greater Manila area.

About CALAX

CALAX is a 45km 4-lane expressway with eight interchanges with operational segments at Laguna Technopark, Laguna Boulevard, Santa Rosa-Tagaytay Road, Silang East, and Silang (Aguinaldo) Interchange, with remaining segments Governor's Drive, Open Canal and Kawit still in construction. When fully completed, CALAX will reduce travel time from CAVITEX (Kawit) to SLEX (Mamplasan Interchange in Biñan, Laguna) from 2 hours to 35 minutes enhancing connectivity between NCR and the

CALABARZON region.
