BOC ZAMBOANGA COLL. BARTE, EXCEEDED ITS MONTHLY AND 2018 ANNUAL COLLECTION!

THE Bureau of Customs [BOC] Port of Zamboanga District Collector Segundo Sigmundfreud Z. Barte Jr., as of Nov.exceeds its revenue collection target for the month of December and the 2018 annual target.

The Zamboanga Customs Coll. Jun Barte was assigned an Annual Collection Target amounting to P 288, 000,000.00 and has already collected a total of P 351,787,450.66 or 22.15% above its annual target.

For the month of December, this port has already collected P 38, 661,548.00 which already surpassed the assigned monthly target of P 25,000,000.00 with a positive deviation of P13,661,548.00 or 53.65 %.

According to Coll. Barte Jr.,the intensified anti-smuggling drive resulted to the rise in the revenue collection from the importation of rice and cement. Liquefied Petroleum Gas (LPG), round logs and refined bleach and deodorized palm oil also contributed to the higher collection records of the port.

The Collection District under Coll. Barte Jr., is among the top performing ports in the country based on the recent collection report from the BOC.



Sa pagkakataong ito mga katoto, buong pusong nag ulat ang matikas na Force Commander, Capt Edgardo T. Hernando PCG ng CGSOF sa mga nagampanang tungkulin sa loob ng isang taon singkad kabilang na ang mga naiambag ng mga tauhan nito sa ibat iba nilang tanggapan sa sub-units katulad ng Special Operations Units (SOU's), Explosive Ordnance Disposal Unit, Coast Guard Anti-Terrorist Unit, kung saan naging instrumento ng tagumpay ng misyong ginampanan simula noong Nobyembre 2017 hanggang 2018.

POE: STRENGTHEN ANTI-BULLYING LAW

F Sen. Grace Poe said the bullying incident involving high school students has prompted the need to revisit the Anti-Bullying Act of 2013 to fill in some gaps as to the role of the schools in dealing with actual cases.

"Anyone who has seen the video of the violent bullying incident would understand that bullying is a despicable act that insults our humanity," she said.

"There is an Anti-Bullying law in place. However, we believe it should be strengthened to require concrete and timely action from schools," Poe, vice-chairperson of the Senate committee on public order, added.

The unfortunate incident should serve as a wake-up call for legislators to examine the law and plug the gaps to make it truly responsive to the problem of bullying.

Republic Act 10627 or the Anti-Bullying Act of 2013, signed by then President Benigno Aquino III, mandates all elementary and secondary schools to adopt policies to prevent and address the acts of bullying in their institutions.

The law defines bullying as "any severe or repeated use by one or more students of a written, verbal or electronic expression or a physical act or gesture or any combination thereof, directed at another student that has the effect of actually causing or placing the latter in reasonable fear of physical or emotional harm

or damage to his property.

Poe stressed that the current law gives the school administrators too much discretion on when to act on the bullying case. "It leaves it up to them to determine whether appropriate action can be taken," she explained. Under the law's "Mechanisms to Address Bullying," it states that:

"If it is determined that bullying or retaliation has occurred, the school principal or the designated school officer or person shall:

- (a) Notify the law enforcement agency if the school principal or designee believes that criminal charges under the Revised Penal Code may be pursued against the perpetrator;
- (b) Take appropriate disciplinary administrative action;
- (c) Notify the parents or guardians of the perpetrator; and
- (d) Notify the parents or guardians of the victim regarding the action taken to prevent any further acts of bullying or retaliation."

"This is why in the current case, even with the numerous videos that have come out, police are saying that they have to wait for Ateneo to notify them and seek their help," Poe said.

"And, this is why the school administration is saying that it still has to determine if bullying has taken place," she added.

The senator said that one possible amendment to the law would require removing the section that gives total discretion to the

school. Poe noted the need for timely response to incidents of bullying. "For example, anti-bullying committees should be formed, which shall act upon reports of bullying within thirty (30) days after the incident," she said, adding that a delayed reaction would be detrimental, as it allows the perpetrator to repeat the bullying act.

The members of the proposed body or committee that would look into the incident should not be related in any way to the parties involved, Poe said.


Furthermore, the alleged perpetrator must be required to take a leave of absence until the investigation is completed, she said. Poe said she would soon file a resolution to hear out concerned stakeholders in a bid to review and amend the law.



Ayon kay Overseas Workers Welfare Administrator Hans Leo Cacdac, ang 109 na napauwing mga OFWs mula sa Middle East ay makatatanggap ng tulong kabilang ang P20,000 cash assistance mula sa kagawaran para sa kanilang maayos na reintegrasyon sa bansa.

"Utos ito ni Labor Secretary Silvestre Bello III. Umaasa tayo na makatutulong ito upang mairaos ang pang-araw araw na gastusin," wika ni Cacdac. Ang mga pinauwing OFW ay lumapag sa bansa noong Disyembre 8 mula sa Dammam, KSA.

Kabilang sa kanila ang 88 manggagawa ng Azmeel Company sa Al Khobar na appektado ng lockdown ng work sites at hindi nakatanggap ng tamang suweldo at overtime pay.

Mayroon ring 18 OFWs mula sa Rakan Trading Contracting Company at 4 na empleyado ng Samama Company ang nagdesisyong umuwi dahil sa mga paglabag sa kontrata ng kanilang Saudi employers.

Dagdag pa ni Cacdac, liban sa pinansyal na tulong, ang mga repatriated OFW ay maaari ring mag-aplay ng tulong pangkabuhayan kung naisin na lamang nilang manatili sa bansa.

Ang 13th-month pay ay ang one-twelfth (1/12) ng basic salary ng empleyado sa loob ng calendar year. "Samakatuwid, ang minimum 13th-month pay na iniaatas ng batas ay hindi dapat bababa sa one-twelfth (1/12) ng kabuuang basic salary na kinikita ng empleyado sa loob ng calendar year," ani Bello.

Kasama sa basic salary ang lahat ng kabayaran o sahod na ibinayad ng employer sa isang empleyado para sa serbisyon kanyang ibinigay, ngunit hindi kasali ang cost-of-living allowance (COLA), profit-sharing payment, cash equivalents ng unused vacation at sick leave credit, overtime pay, premium pay, night shift differential pay, holiday pay, at ang lahat ng allowance at monetary benefit na hindi itinuturing, o hindi bahagi ng regular o basic salary ng empleyado. Sa parehong Labor Advisory, nagbigay si Bello ng sample illustration ng formula sa pagkukuwenta ng 13th month:

Kabuuang suweldo na kinita sa kasalukuyang taon = katapat na 13th month pay 12 buwan

Kailangang bayaran ng lahat ng employer ang kanilang rank-and file employees ng kanilang 13th-month pay, anupaman ang uri ng kanilang empleo, at kung anupaman ang pamamaraan ng pagbabayad ng kanilang sahod, basta nagtrabaho ang empleyado ng isang buwan sa loob ng kasalukuyang taon. Ang natatanging kondisyon lamang ay nakapagtrabaho ang manggagawa ng isang buwan sa loob ng kasalukuyang taon.

BI Rescues 9 Korea-Bound Human Trafficking Victims

PASAY, Philippines—Bureau of Immigration (BI) officers at the Ninoy Aquino International Airport (NAIA) have rescued nine more suspected human trafficking victims who disguised themselves as tourists in attempting to leave for South Korea.

In a report to Immigration Commissioner Jaime Morente, BI Port Operations Division Chief Grifton Medina said the passengers were about to board an Air Asia flight to Taipei last Thursday when they were intercepted by members of the bureau's travel control and enforcement unit (TCEU).

"They admitted that they were actually destined for Korea where they were illegally recruited to work as orange pickers in a plantation in Jeju Island," Medina said.

He added that the passengers initially claimed they were traveling as tourists to watch a Nanta acrobatic exhibition show in the said island.

"When asked, they could not explain and had no idea what the Nanta show is all about and their answers to questions by immigration officers were highly inconsistent," Medina said. "When pressed on the actual purpose of their trip, they confessed that they were hired to work with a promised monthly salary of P65,000."

The victims, whose identities were not divulged due to a prohibition in the anti-trafficking law, were turned over to the Inter-Agency Council Against Trafficking (IACAT) for assistance and further investigation.

NAIA Terminal 3 BI-TCEU Chief Glen Comia observed that the apprehension occurred barely three days after immigration officers also intercepted eight trafficking victims who were illegally recruited to work in Cyprus.

"It appears that only one syndicate was behind the recruitment of these victims," Comia said. "This is a well entrenched trafficking syndicate that operates in both Europe and Asia." As in the case of the Cyprus-bound victims, the Korea-bound passengers also did not know each other and related that they only met at an office in Ermita where they were briefed by their recruiters before their trip.

The victims, who all hail from far flung areas in the provinces, also recounted in writing the ordeal they suffered as they lost their life savings due to the huge sums they paid their recruiters for processing their travel papers.
