PGC CONDUCTS ORIENTATION ON E-CLIP

In order to capacitate local government units and national government agencies in the execution of the reintegration program and achieve reintegration success for former rebels in the community, the Provincial Government of Cavite (PGC) thru the collaborative efforts of Provincial Social Welfare and Development Office (PSWDO) and Department of Interior and Local Government (DILG) conducted an orientation on the Enhanced Comprehensive Local Integration Program (E-CLIP) and Implementing Guidelines for the Provision of DILG- Administered Package Assistance.



CLEAN UP ACTIVITY IN TOCLONG, KAWIT: The advocacy on environmental awareness continues as Governor Boying Remulla and Vice Governor Jolo Revilla visited the locals of Rockwell Subdivision in Barangay Toclong, Kawit on March 5, 2019 to spearhead the Lingap sa Kalikasan Program. During the event, thousands of residents swept the streets and collected garbage for proper waste disposal. Other guests who attended and expressed their support to the advocacy include visiting former Special Assistant to the President Bong Go, Board Member Rainier Ambion, Indang Municipal Councilor Ping Remulla, Tanza Municipal Councilor Lito Langit and WOW Party List Representative Patty Keng. The orientation on February 27, 2019 was attended by municipal/city social welfare and development officers at the Ceremonial Hall of the provincial capitol in Trece Martires City.

OIC-PSWDO Ms. Darylvy Avila acknowledged and warmly welcomed all the participants while Provincial Administrator for Community Affairs Mr. Alvin Mojica graced the event and delivered his message focusing on the significance of being prepared in providing social welfare services for rebel returnees and their involvement to attain a holistic peace in the province.

The orientation proper was led by Local Government Operation Officer II Mr. Ramon Nedic. He elaborated the contents of DILG-DND Joint Memorandum

Circular No. 2018-01 focusing on the Implementing Guidelines for the Provision of DILG-Administered Package of Assistance for Former Rebels (FRs) and Militia ng Bayan (MB). The roles of DILG, Local Government Units (LGU), Department of National Defense (DND), Armed Forces of the Philippines (AFP), Philippine National Police (PNP), E-CLIP Committee (ECC), Joint AFP-PNP Intelligence Committee (JAPIC) and the Provincial/Highly Urbanized City Peace and Order Council who are connected in the implementation of the program were discussed during the session. He also reiterated the proper handling of the program phases and process, the required documents and the mechanism for security and monitoring of the rebel returnees.

In the afternoon, the resource speaker presented a short overview of DILG Circular No. 2018-17: Implementing Guidelines and Procedures for the Disposition of Firearms, Explosives and Ammunition (FEA) of FR and MB and DILG MC 2018-105: Implementing Guidelines for the Construction of Halfway House for FR and MB. After the discussion, the participants were asked to prepare an action plan on E-CLIP for year 2019.

Ms. Precyl Ramos, Social Welfare Officer III, expressed her gratefulness to all the participants who took time despite their busy schedules. She also shared her thoughts about the implementation of E-CLIP program as she echoed the provincial government's commitment to be an instrument in the proper reintegration of FRs and Mbs. 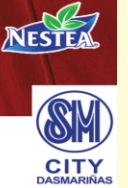

Shipping lines agree to load out more empty containers at MICP!

ON 5 March 2019, the District Collector of Manila International Container Port (MICP), Atty. Erastus Sandino B. Austria, met with all international shipping lines country operations managers and heads together with the port operator, International Container Terminal Services, Inc. (ICTSI), to agree on solutions to bring yard utilization to ideal levels and resolve the recurring issue on the difficulty in returning empty containers. During the meeting MICP reached an agreement with the shipping lines to load out more empty containers per day.

Evergreen Shipping Agency, Wan Hai Lines, CMA-CGM/APL, Ben Line Agencies, Cosco Shipping Lines, KMTC, Hyundai Merchant Marine, TMS Ship Agencies, One Network Express, Yang Ming Shipping, SITC Container Lines, OOCL and Namsung Shipping agreed that they each will be loading an additional 100 to 1800 Twenty-foot Equivalent Units (TEUs) on top of the empty containers they load out on workdays. These carriers will be taking advantage of the additional double transaction slots that ICTSI will be opening on weekends starting on March 9 to 10, 2019. The rest of the shipping lines also agreed to do the same.

During the last two weekends, ICTSI sent an advisory to its clients that they will be accepting double transactions. However, ICTSI said that few consignees returned their empty containers. As a reply, the shipping lines committed that they will convince their clients to take advantage of the downtime on March 9 to 10 and on every succeeding weekends to return more empty containers.

In the meeting, MICP District Collector Austria highlighted a large discrepancy between the actual number of empty TEUs being loaded out onto vessels and the capacity of these ships, a matter that all parties agreed to immediately resolve.

"On average, far less than 2000 empty TEUs are loaded for export in a 24-hour cycle," Atty. Austria said. "That is an unacceptable number."

When asked if they were co-loading, the shipping lines said they have been co-loading amongst themselves. As agreed during the meeting more carriers will co-load empty containers.

The carriers explained that they can bring more containers from their depots to the terminal, and have more empty containers loaded out if they are given more time to complete the process.

Currently, ICTSI gives the carriers around 3 to 4 nights before a ship's arrival to bring their empty containers at the terminal instead of 3 to 7 days they said they need to allow them to evacuate more empty containers from the country.

ICTSI replied that they have implemented the 3-to-4-day policy to prevent delays on a ship's schedule. They explained that if they accept containers too early the containers will be stacked at the bottom and loading them on to the vessel will require more crane moves leading to delays in the loading schedule.

"I think the increase [in TEU load out] you are looking for is the additional double transactions on weekends," Mr. Chris Lozano of ICTSI said.

And, many of the shipping lines present at the meeting agreed to take advantage of the downtimes on weekends in order to load out more empty containers.

If successfully done, MICP can see around 17,500 empty TEUs loaded out in a week compared to its high average of only 10,000 TEUs.

ROBINSON'S P18-B RESORT PROJECT STARTS EXCAVATION AS EMB CAL



The Office of the Building Official (OBO) of Cebu City has granted the Universal Hotels and Resorts Inc. (UHRI) the excavation permit to construct a 4-storey building for the affected offices that will be demolished.

OBO chief Engr. Josefa Ylanan told media that UHRI applied for the excavation as they started the horizontal civil works in the more than 8 hectare city property at Kawit island, where the Resort Casino complex will be build.

"We issued the permit to do the excavation in preparation for the foundation. The main building permit application is on process. It is being returned to the engineer for corrections," she added.

After the excavation, the construction of a P20 million 4-storey building will follow that will house the SRP Management Office, Cebu City Disaster Risk Reduction and Management Office and the Association of Barangay Councils (ABC) office at the Magellan's Park fronting the Cebu City Hall.

MANDAUE BIZMEN FEARS OF HARASSMENTS AFTER MAYOR CLOSES HOTEL

Businessmen based in Mandaue City yesterday expressed concern and fear on possible harassments by its city government when it ordered the closure of Big Hotel, Big Hotel Suites and Linear Coffee Shop managed and operated by Cenore Corporation and Travelbee Management Corporation.

Lawyer Deolito Alvarez, legal counsel for Big Hotel said "The closure order notice was served. The hotel, however, is in normal operation and closure was not implemented after I talked to Atty. Elaine Bathan. We have set meetings to discuss issues pertinent to the dispute.

The owners of Big Hotel are businessmen, not politicians. It is sad that businesses are often victimized by dirty, heartless and evil hands of politicians."

He cited having "simple misinterpretation" of some provision/s by the legal office of city government that can be rectified and not go into the extreme of closure.

The Mandaue City government on February 26, 2019 issued a closure order of these three establishments for alleged contract violations and for operating without business permit or registration.

The closure order signed by Mayor Luigi Quisumbing was served to Travelbee Management Corp. for Big Hotel for alleged anomalous contract.

Another order was served to Travelbee Management Corp. for Big Hotel Suites and Linear Coffee Shop for operating without business permits, for failing to pay business taxes and fees for calendar year 2019, and for employing a person who has not paid occupational tax prior to employment.

This business venture had already costed more than P 90 million in investments and at least 150 hotel employees. The Mandaue City Council in its regular last Wednesday ratified the deed of assignment between Katumanan Hardware and Cenore Corp. which legalized the operations of Big Hotel.

The Bureau of Immigration (BI) is deporting two wanted Korean fugitives arrested recently in the cities of Manila and Mandaluyong by operatives from the bureau's fugitive search unit (FSU).

BI Commissioner Jaime Morente identified those arrested as Oh Gwangrok, 48, and Park Seungjae, 44, who are now detained at the bureau's detention facility in Camp Bagong Diwa, Taguig City while awaiting deportation.

"We are sending them back to Korea where they are wanted by authorities for serious offenses. The Philippines is not a sanctuary for foreign criminals," Morente declared.

It was gathered that FSU operatives headed by BI intelligence officer Bobby Raquepo arrested Oh in the vicinity of Remedios Circle in Malate, Manila last Monday on the strength of a warrant of deportation issued by Morente.

The warrant was issued pursuant to a summary deportation order that the BI board of commissioners issued against Oh on Nov. 21 last year for overstaying and holding an expired passport.

Oh, according to the Korean embassy, is wanted for fraud involving US\$48,000 and embezzling a victim's car worth US\$41,000. Park, on the other hand, was arrested Tuesday inside his unit at the Tivoli Garden Residences in Mandaluyong.

Park, who is also an undocumented alien for holding an expired passport, is reportedly arrested for smuggling and violating Korea's customs act.

He allegedly smuggled 11 types of counterfeits, including federal reserve bonds worth US\$ 500 million, in violation of an import prohibition on forged currency, bond or stock. Investigation also revealed that Oh had been overstaying in the country since July 2012 while Park failed to extend his stay as a tourist since arriving here on December 2017.

BI AGENTS NAB 2 US FUGITIVES

Operatives from the Bureau of Immigration (BI) have arrested two American fugitives wanted by US federal authorities on assault and battery charges.

BI Commissioner Jaime Morente said the Americans were arrested recently in separate operations conducted by elements from the Bureau's Fugitive Search Unit (FSU) in the cities of Baguio and Mandaluyong.

"Like all the other foreign fugitives whom we have arrested in the past, we will deport these two undesirable aliens and ban them from re-entering the Philippines," Morente said in a statement. "They have no place in our country, as their presence here poses a risk to our people," he added.

Arrested on March 1 inside the SM Mall in Baguio City was 46-year-old Apollo Cioffi, who is wanted by authorities in California for assault. A superior court in San Francisco has reportedly issued a warrant for his arrest.

The US Embassy did not give a detailed account of Cioffi's alleged crime but California's penal code law defines

BI-FSU operatives also arrested on March 5, 32-year-old William Schweizer inside his unit at the Tivoli Garden Residences in Mandaluyong.

Schweizer is the subject of an arrest warrant issued by a circuit court in Broward County, Florida after he was charged with felony battery by strangulation.

Under Florida statutes, felony battery and domestic battery by strangulation occurs when a person actually and intentionally touches another person against their will and causes them great bodily harm, permanent disability, or permanent disfigurement.

BI-FSU Chief Bobby Raquepo said both Cioffi and Schweizer are overstaying and undocumented aliens as their passports were already revoked by the State Department. Raquepo said Cioffi had hidden in the country since March 10 last year while Schweizer has been here since July 2015.

BI ARRESTS RUSSIAN FUGITIVE WANTED FOR FRAUD

MANILA, Philippines—Bureau of Immigration (BI) personnel arrested yesterday afternoon a Russian fugitive wanted in his home country for fraud.

Likharev Anton, 37, was caught by Immigration Officer Catalino Alfonso and staff Justin Marcial of the BI Tourist Visa Section after he attempted to extend his temporary visitor's visa at the BI's head office in Intramuros, Manila. Records show that Likharev arrived in the country in 2016 as a tourist and has not left since.

He is the subject of a Summary Deportation Order signed by the BI Board of Commissioners in December 2018 following information that he is wanted by Russian courts for large-scale crimes involving acquisition of other people's property by means of deceit, in violation of Article 159, part 4 of the Criminal Code of the Russian Federation.

BI Commissioner Jaime Morente commended the personnel who intercepted Likharev. "These men deserve commendation for their vigilance, which led to the arrest of this fugitive," said Morente. "We will not allow fraudsters like him to hide in the Philippines, as they pose a risk to public interest," he added.

Likharev made headlines in 2017 after being arrested for violating the Fisheries Code of the Philippines and a municipal ordinance when he killed a green sea turtle with a spear in Dauin, Negros Oriental. He reportedly denied that it was intention to kill the turtle, and alleged that he did not know that the area is a marine sanctuary.

He was turned over to the BI Fugitive Search Unit for commitment to the BI's detention facility in Bicutan, Taguig pending the implementation of his deportation.

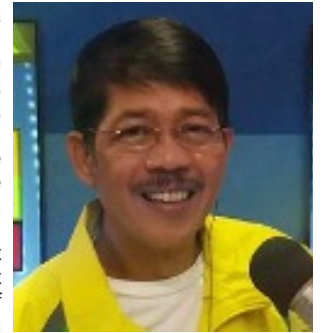
