**O**f the 10 Cebuano District Representatives, at least two expressed frustration over reported and alleged vote-buying of Speakership contenders in the House of Representatives.

Representatives Raul del Mar (North District, Cebu City) and Pablo John Garcia (Third District, Cebu Province) told DAILY TRIBUNE that their votes are "not for sale."

"I'll be voting for Rep. Lord Velasco as I believe he'll make a better Speaker among those vying for the position. I will never receive a single centavo, not even a million pesos for my vote."

There are proposals from the Liberal Party and the Visayas bloc that I am a member of to vote as one, but I have already made known to them that I have already committed to vote for Rep. Velasco," Del Mar said.

For his part, Rep. Garcia, said "I have not been offered anything for my vote. I'm not part of the Visayas bloc so I cannot speak for the group. It's too early in the game. The field could broaden, or narrow. A lot could happen in six weeks."

As of the press time, other Cebuano Representatives Rodrigo Abellanosa (South District, Cebu City), Eduardo Gullas (First District, Cebu Province), Wilfredo Caminero (Second District, Cebu Province), Janice Salimbangon (Fourth District, Cebu Province), Duke Frasco (Fifth District, Cebu Province), Emmanuel Ouano-Dizon (Sixth District, Cebu Province), Peter John Calderon (Seventh District, Cebu Province) and Paz Radaza (long congressional district, Lapu-Lapu City) were unable to reply on the issue. Earlier, former Speaker and Davao del Norte Representative Pantaleon Alvarez disclosed that there were reports to plan to "buy votes" for the speakership in the House of Representatives which ranges from P500,000 to P1 million per representative.

This according to one of the reelected Representative has even increased to P7 million per representative. The incoming 18th Congress is composed of 270 members of the House of Representatives, including the 54-member Partylist bloc.

There are 95 elected Representatives from the Partido Demokratikong Pilipino-Lakas ng Bayan (PDP-Laban); 37 from the Nacionalista Party (NP); 33 from the Nationalist People's Coalition (NPC); 28 from the National Unity Party (NUP); 18 from Liberal Party (LP) and five from Lakas-Christian-Muslim Democrats (CMD).

Vying for the speakership aside from Alvarez are: Leyte Representative Martin Romualdez, Marinduque Representative Allan Velasco, Pampanga Representative Aurelio Gonzales and Taguig Representative Allan Peter Cayetano.

## NO TO SPEAKERSHIP PAY-OFF

### LABELLA TO FIRE AND HIRE MORE THAN 5K CASUAL/JOB ORDER EMPLOYEES AS HE INVITES PRO-OSMENA COUNCILORS TO HIS FOLD

Cebu City Mayor-elect Edgardo Labella admitted that there are casual, job order (JO) and barangay workers, who will be terminated effective July 1, 2019 as these openly campaigned against him during the last elections.

This as a committee was formed by him to review and evaluate the performance of the City Hall casual and job orders including barangay workers.

While, he has not yet assumed as City Mayor, last May 31 was the last day for job order employees, who were part of the Barangay Mayor's Office (BMO).

"I don't mind if they voted in favor of the opposite side but if they campaign hard and involved in mudslinging and character assassination, of course, these are considered because it is not fair to our supporters," he told media.

"You have to take into consideration that there maybe others who have been active campaigning against our group, our candidates, that should be considered because it is not fair for our supporters that there are those who actively campaigned against us will be renewed while there are supporters who worked so hard for us...even their careers, they risked their opportunities," he added.

"I am a fair man. I am not a vindictive man. That's precisely the reason why I created a committee will be validated by me and other political personalities of the group. We will ask the barangay captains, the officials who are with us," Labella said.

As he assured that he will not follow the outgoing administration that ordered the "sweeping termination" of all allies of the previous administration. There are more than 5,500 casual and job order employees presently hired by the administration of outgoing Mayor Tomas Osmena.

"To be frank about it, those who worked hard against us and even involved in mudslinging and character assassination against our group, then we will take cognizant of their posturing and those demeanor by them because we have to take into consideration that we also have our supporters who worked hard for us," Labella reiterated.

He said "Their sacrifice should not go unnoticed by us. We have to give importance to their help and their sacrifices vis-a-vis those of instead of just working, even get involved in mudslinging and political activity against us."

As this developed, Labella welcomed Bando Osmena Pundok Kauswagan (BOPK) City Councilors to join the Partido Barug-PDP Laban as he wants an inclusive governance so anyone from the other political fence is welcome to become part of his administration. City Councilor Jerry Guardo, who lost in his reelection bid yesterday told media that he is fully supporting the incoming Labella administration. "This is my personal choice, I will support the incoming Mayor Ed Labella," Guardo added.

The pronouncement of Guardo, will be plus one barangay captain for Labella as Guardo's wife Aileen is the barangay captain of Sambag Uno. Presently, there are 54 of the 80 barangay captains in Cebu City that are supporters of outgoing Mayor Osmena.

The incoming City Council by July 1 has nine councilors with BOPK and seven PDP Laban plus the ex officio councilors from Association of Barangay Councils (ABC) President and Sanggunian Kabataan Federation (SKF) President, who are both with BOPK. Labella's party is the minority bloc.

"Well of course, everybody is welcome... As I've said our system of governance would be inclusive, Inclusive in the sense that we are willing to adopt and embrace everyone who wants to have a better Cebu City," Labella added.

It is noted that the said materials is Imported by MEARC PHILTRADE CORPORATION which arrive at the Port of Masinloc on 12 August 2018 from Chinhae, Korea.

So, talagang ang Neutralized Phosphogypsum, is NOT ALLOWED FOR IMPORTATION under table 10.1 of the DAO... To story short..the said materials is RADIOACTIVE DUE THE PRESENCE OF NATURALLY OCCURRING RADIOACTIVE ELEMENTS.

### BOC DECENTRALIZES AMO PROCESSES AND SIMPLIFIES ITS ACCREDITATION PROCEDURES!

IN its aim to expedite processing at the Bureau of Customs - Account Management Office (BOC-AMO), the bureau decentralizes its AMO processes and simplifies its accreditation procedures. Customs Memorandum Order (CMO) No. 19-2019 issued on April 16, 2019 by Commissioner Rey Leonardo B. Guerrero allows the renewal of customs brokers' accreditation and the activation of the Client Profile Registration System (CPRS) of entities accredited by other government agencies to be processed at the Collection District nearest to their principal place of business.

The CMO aims to reduce the number of signatories from four to two, instead of having it approved through AMO, Office of the Deputy Commissioner for Intelligence Group and the Office of the Commissioner, now, with the CMO, brokers' accreditation will only be processed at the local Customs Intelligence and Investigation Service (CIIS) and at the office of the District Collector.

The activation of the customs broker's CPRS and the preparation of the Certificate of Accreditation (COA) shall be done by the AMO Head Office. Signed COAs will then be transferred to the District Collectors for release to the customs brokers.

CPRS activation of entities accredited by other government agencies will be done at the Office of the District Collector upon the receipt of endorsement with the attached requirements from concerned government agencies.

This move of the bureau is only part of the various information systems that BOC has introduced in line with the ten-point priority program of Commissioner Guerrero.

Nadiskubre na aabot sa P154-B ang pondong nasayang nang maibayad ito sa nasabing bogus dialysis treatment claims. "Hopefully, the NBI can get the assistance of the new PhilHealth management team," dagdag ni Guevarra.

Nakalabas ng kulungan si Sy makaraang nagpiyansa kaugnay ng kinakaharap na kasong estafa at falsification of public documents kaya pinalaya na sa NBI nang payagan ito ng Manila Regional Trial Court (RTC) na magpiyansa para sa pansamantalang kalayaan nito.

Samantala siniguro ng isang kongresista na iimbestigahan ng Kongreso ang usaping ito ayon kay Camiguin Lone District Rep. Xavier Jesus Romualdo at hihintayin na lamang nila ang pagbubukas ng 18th Congress at ang pagbubuo ng mga komite para tuluyan nang masimulan ang imbestigasyon.


