Cavite PCPC Launches the First Milk Feeding Program in Trece Martires City

In accordance with Republic Act No. 11037 or the Masustansiyang Pagkain Para sa Batang Pilipino Act – a law on the establishment of a national feeding program for undernourished children in public day care centers, kindergarten and elementary schools, the Cavite Provincial Council for the Protection of Children launched the first Milk Feeding Program in the City of Trece Martires on December 16, 2019 at Sunshine Ville Child Development Center, Barangay Cabuco.



USPA-CAVITE HOLDS CHRISTMAS PARTY 2019: Capping the year in the season of giving, the United Solo Parents' Association-Cavite Inc. held its Christmas party on December 19, 2019 at the Ceremonial Hall, Provincial Capitol Building, Trece Martires City. Ms. Analie B. Rodil, USPA President welcomed the solo parents and gladly informed the participants of the many gifts in store for them. Ms. Precyl T. Ramos, Social Welfare Officer III of the Provincial Social Welfare Development Office welcomed the new members and thanked those who continuously support the solo parents' activities and programs. During the event, a Re-orientation of the Solo Parents Welfare Act of 2000 (RA 8972) and its Proposed Amendments was facilitated by Ms. Marisa D. Basada, DSWD IV-A Solo Parent Focal Person. The participants were enlightened and encouraged to support the proposed amendments and Senate bills filed for their additional benefits. They also enjoyed the many prizes from the raffle which made the activity more exciting. In closing, Ms. Felipa Servanez, PSWDO Head, thanked all the 68 solo parents who were present greeting them a Merry Christmas and a Happy New Year. (PICAD)

Selected as pilot LGU of the newest program, Trece Martires City is one of the LGUs with high number of undernourished children due to the transfer of residences of former informal settlers from other cities. The PCPC aims to assist the Child Development Center (CDC) with high incidence of undernourished children by providing the Milk Feeding Program. With the target 100 beneficiaries from Sunshine Ville 1 & 2, the program will benefit the vulnerable group of children aged 2-4 years old.

Mayor Gemma Lubigan in her short message thanked the provincial government and the PCPC for selecting the City in the program launching. She urged the parents to give their full support to the program to improve the nutritional status of their children. Likewise, Ms. Nora de los Santos, City Social Welfare and Development Officer reminded the parents to avoid giving their children artificial drinks. The City government provided playpen, educational materials, building blocks and rubber mats during the launching. On the other hand, Ms. Brendalyn Salazar, Social Welfare Officer IV of the PSWDO gave a brief orientation of the program from identifying a CDC with high prevalence of underweight children, initial weighing, deworming and monthly reweighing to monitor and evaluate the progress weight of the child.

Aside from the supplementary feeding, mothers' class sessions will also be conducted among the guardians and mothers of the recipients. The 120-day MFP will start on January 6, 2020.

Also present in the event were City Councilors, Provincial and City Social Welfare and Development staff, and parents of the children beneficiaries. (PICAD)

BOC-Receives Freedom of Information Award!

THE Bureau of Customs [BOC] under the stewardship of Customs Commissioner Rey Leonardo B. Guerrero, on December 12, 2019, was recognized by the Freedom of Information - Project Management Office (FOI-PMO) under the Presidential Communications Operations Office (PCOO) during the 2019 Freedom of Information Awards held at The Peninsula Manila Hotel in Makati City.

The BOC was commended for being one of the top performing agencies in the Electronic Freedom of Information (eFOI) Portal () and for its exceptional and significant contribution to the FOI's progress and development.

The Bureau, through the BOC - Customer Assistance and Response Services (CARES) under the Public Information and Assistance Division [PIAD], has been consistent in providing feedback and building a strong bridge between the government and the public. To date, a total of 49,908 resolved inquiries and/or complaints were recorded by the BOC-CARES since January 2019.

In his speech, PCOO Secretary Martin Andanan emphasized that FOI, in order to be an effective tool for governance, must be implemented across the bureaucracy.

It was through the Executive Order (EO) No. 2 series of 2016 signed by President Rodrigo Roa Duterte on July 23, 2016 that made the FOI fully operational, providing the public with a constitutional right to information and full public disclosure and transparency in the public service.

The FOI Awards was established in 2017 to recognize the efforts of government agencies individuals and organizations that contributed to the realization of its goals.

Last June 17, 2019, the BOC created the Customer Care Portal System available at the Customs website which serves to not only address customer concerns but also promotes transparency in the Bureau and contribute to its anti-corruption efforts.

Bureau Top Management Undergoes ISO Risk Management Training!

AS part of the Bureau of Customs' (BOC) bid to attain ISO 9001:2015 certification, BOC top management on Tuesday December 10, 2019 attended the ISO 31000 Risk Management Course conducted at the SGS Academy, Makati City.

Attendees were composed of BOC's top management who were led by Commissioner Rey Leonardo B. Guerrero together with Deputy Commissioner Donato B. San Juan (IAG), Deputy Commissioner Raniel T. Ramiro (IG), Deputy Commissioner Teddy S. Raval (EG) and Assistant Commissioner Vincent Philip C. Maronilla (PCAG). The group were also joined by Collectors from the various collection districts of the Bureau.

ISO 31000 Risk Management - Principles and Guidelines is a risk management standard intended to assist large and small private and public organizations to effectively manage risks associated with their operations. Effective risk management strategies can be applied to risks with both potentially positive and negative impacts on the business.

The training aimed to provide top management with better understanding in identifying opportunities in order to improve incident management, minimize losses and improve organizational learning and resilience. The attendees were also given activities to further improve their knowledge with regards to risk identification,

BOC Davao hosts 13th BIMP-EAGA Heads of Customs Meeting!

THE BOC Davao hosted the 13th Brunei Darussalam Indonesia Malaysia Philippines East ASEAN Growth Area (BIMP-EAGA) Heads of Customs (HoC) 2019 Meeting last December 9, 2019 at Waterfront Insular Hotel in Davao City.

District Collector of Port of Davao, Atty. Erastus Sandino Austria chaired the said meeting alongside Deputy Commissioner for Assessment and Operations Coordinating Group (AOCG) Atty. Edward James Dy Buco where primary initiatives of each country on achieving BIMP-EAGA Vision 2025 (BEV 2025) were discussed.

For the Philippines, the event showcased the implementation of the Goods Declaration Verification System - a modernized and electronic system which enables importers and brokers to obtain real-time information on the status of their goods declaration online and the WCO Cargo Targeting System (CTS) - a tool for advanced profiling of shipments before they arrive at Philippine ports using the manifest data given.

"BIMP-EAGA today has reached peaks in its thrust of accelerating socio-economic development of its member countries. We have exerted efforts for easier trade facilitation of goods and services. Definitely, the role of the Bureau of Customs is pivotal in the realization of BEV 2025." Atty. Erastus Sandino Austria, said.

As of this time, the working group meeting of the BIMP-EAGA Heads of Customs will continue to pursue progress in achieving its roadmaps for BEC 2025. The members have also decided that the next host country for the 14th BIMP-EAGA HoC will be Brunei Darussalam.

BOC Reiterates the Guidelines on Duty and Tax-Free Importation!

THE Bureau of Customs [BOC] reiterated on Monday, December 16, 2019 the guidelines on De Minimis importation. The Di Minimis rule means that if the value of the imported goods, does not exceed the P10,000.00 no duties and taxes will be charged.

Under Customs Memorandum Order No. 28-2016 which provides for the guidelines for the implementation of Customs Administrative Order No. 02-2016, all imported goods with a value of no more than P10,000.00 and are not classified as prohibited shall enjoy duty and tax-free privilege.

The De Minimis Value rule covers all importations for consumption entered through various modes such as postal consignments, passenger baggage, consolidated shipments, express consignments and on-board couriers transported through air or sea. It also covers goods of commercial quantity and those regulated by other government agencies.

However, importation of cigarettes and other tobacco products, wines and spirits shall still be subjected to excise tax regardless of its value due to public health reasons as pronounced under Republic Act No. 10351, otherwise known as the Sin Tax Law.

BOC-Port of Manila seizes P54-Million worth of Misdeclared Sugar!

THE Consistent to its mandate in protecting the borders by curbing customs fraud, the Bureau of Customs-Port of Manila seized P54-million worth of Korach-conditioned Refined Sugar misdeclared as steel, tex screw, clamp, nails and hardware fittings contained in forty-eight (48) containers.

The shipments from China arrived on different dates on August and September 2019 and were consigned to RZTREC and TRACLEF Trading. Said shipments were alerted on November 8, 13 and 14, 2019 and the examination started on November 13, 2019. After the physical examination of the containers, Warrants of Seizure and Detention were issued for violation of Section 1400 in relation to Section 117 of the CMTA and Republic Act No. 10845 otherwise known as Anti-Agricultural Smuggling Act of 2016.

In accordance with Letter (e), Section 3 of Republic Act No. 10845, the crime of large-scale agricultural smuggling as economic sabotage, involving sugar, corn, pork, poultry, garlic, onion, carrots, fish, and cruciferous vegetables, in its raw state, or which have undergone the simple processes of preparation or preservation for market, with a minimum amount of one million pesos (P1,000,000.00), or rice, with a minimum amount of ten million pesos (P10,000,000.00), as valued by the Bureau of Customs (BOC), is committed through misclassification, undervaluation or misdeclaration upon the filing of import entry and revenue declaration with the BOC in order to evade the payment of rightful taxes and duties due to the government.

The BOC continues to be vigilant against customs fraud and fulfill its mandate to enhance border security. For the year

2019, Port of Manila has seized a total of P314.506 million worth of misdeclared goods - 17.28% higher than the 268.161 million worth of apprehensions last year.

Relatedly, the Sugar Master Plan Foundation, Inc. awarded the Port of Manila, a Certificate of Appreciation, last 11 December 2019, for the recent apprehension of smuggled sugar.

BOC: Normal Import Procedures for Foreign Donations!

THE IMPORTED international donations shall be subject to payment of customs duties and taxes, and to normal procedures for the processing of imports, according to the Bureau of Customs.

They may be exempted from payment of customs duties and/or taxes if the consignee is a (1) National Government agency; (2) a foundation/relief organization registered with the Department of Social Welfare and Development (DSWD) of the Philippines; (3) a non-stock, non-profit educational institution; (4) or a disabled person.

To avail of the duty and tax exemption on the importation of international donation, a Tax Exemption Indorsement (TEI) must be secured from the Department of Finance-Revenue Office.

The requirements in applying for a TEI include (1) Recommendation/endorsement for duty and/or tax-exempt from the appropriate government agency (DSWD, NEDA, DepEd, CHED, etc.); (2) Letter Request addressed to the Secretary of Finance (Attention: Director IV, Revenue Office); (3) Import Bill of Lading (BL)/Airway Bill (AWB); (4) Import Invoice; (5) Packing List (PL); (6) Deed of Donation; and other documents, as may be required by the DOF.

The approved TEI shall be transmitted by the Department of Finance - Central Records Management Division (DOF-CRMD) to the Bureau of Customs -Tax Exempt Division (BOC-TEED) for transmittal to the proper BOC-Collection District for processing. The public is advised to follow the proper procedures in importing foreign donations to avoid unnecessary charges.

Customs NAI Intercepts P141M Worth of Drugs

AS part of the Bureau of Customs' (BOC) mandate to secure the country's borders, the port of NAI today December 18, 2019 presented 20.8 kilos of methamphetamine also known as "shabu" which was intercepted at the FEDEX warehouse in Pasay City.

The illegal drugs were concealed in two parcels which were declared as speakers and shipped from the United States and estimated to have a street value amounting to Php 141,440,000 million pesos. These were discovered during the examination conducted by BOC personnel which resulted to the interception of 20.8 kilos of white crystalline substance tested positive for methamphetamine.

The seized drugs shall be turned over to the Philippine Drug Enforcement Agency (PDEA) for further investigation. The importation of dangerous drugs is a crime punishable under RA 9165 (Comprehensive Dangerous Drugs Act of 2002) in relation to RA 10863 (Customs Modernization Tariff Act).


The latest discovery of illegal drugs is the result of the continued efforts of the BOC in coordination with PDEA and other members of NAI Inter-Agency Drug Interdiction Task Group (NAIA-IADITG). The Bureau remains vigilant in its duty to guard the country's borders and prevent the entry of illegal contrabands.

CEBU CITY IMPOSES INFANT-FRIENDLY FACILITIES IN RESTROOMS FOR BOTH PUBLIC/PRIVATE ESTABLISHMENTS

The Cebu City Council in its regular session has passed an ordinance providing for infant-friendly facilities in the restrooms on both public and private establishments in the city. North District City Councilor Alvin Dizon, who authored the ordinance said the city has to implement modern parenting and caregiving methods in especially in public places and infrastructures must be accessible and catch up with the responsibilities of modern parenting because the balance of parental responsibilities has continued to change and policies should be evolving to meet the needs of modern families.

"The idea of putting infant-friendly facilities in public restrooms for women, men and Persons With Disabilities(PWDs) is a sign of progress because it sends a strong message that society no longer expects that only mothers bear the responsibility of parenting," he cited.

By infant-friendly facilities, it shall include a baby changing station or table or other device suitable for changing the diaper of a child which must be physically safe, sanitary, and convenient, and a baby holder which is a device for securely holding a baby.

The ordinance will cover government or public buildings that is accessible to the public and is owned or managed by the Cebu City government while private establishments mean shopping malls, theaters or movie houses, convention centers, sports arenas, museums, health facilities such as hospitals and clinic/diagnostic centers, mortuaries and gasoline stations that have restrooms opened to the public, entertainment centers such as zoos and permanent amusement parks, supermarkets, banks, hotels and pension houses, restaurants with seating capacity of 50 persons or more and passenger terminals. This excludes nightclubs or bar which prohibits minors from entering.

The standards for the infant-friendly facilities should comply with 1.) provide at least one (1) safe, sanitary, convenient and publicly accessible unisex baby changing facility or changing station in men, women or PWDs restroom as the latter is considered as universal restroom and one(1) baby holder for men, women or PWDs restroom.; 2.) if the building has several floors, then, install one(1) unisex baby changing facility or changing station per gender or in the PWDs restroom one each publicly-accessible floor.; 3.) The baby changing facility should be strong and durable with a suitable weight capacity of 30kg and must have a trash bin and a washing area while the baby holder must have a weight capacity of 20kg.; 4.) The baby changing facility and baby holder shall be noted on the toilet's main door and a signage above the changing table shall be posted to read: "DIAPER CHANGING STATION.. Reminder: Always stay with your baby when using this table."; 5.) building owners must post signs clearly directing people to the nearest changing table and baby holder. If there is a central directory, the location of the baby diaper changing stations and baby holder must be so indicated.; 6.) existing baby diaper changing stations must comply with the standards set forth in this ordinance and should be maintained, repaired and replaced as necessary to ensure safety and ease of

use, and to be cleaned with the same frequency as the restroom in which it is located.; 7.) the standards apply to existing buildings and establishments mentioned under government or public buildings and private establishments and to new constructions or renovations of structures of public or private buildings.; and 8.) for certain establishments with small to medium size of restrooms and the installation may obstruct entrance to and exit from the restroom, the Office of the Building Official(OBO) shall require specifications to ensure safety and convenience.

Exempted from this ordinance are restaurants with a seating capacity of 50 persons or more operating inside a shopping mall and there is an available centralized baby changing facility located 100 meters from the restaurant and if the installation of the baby changing facility and baby holder, as certified by the Office of the Building Official(OBO),is not physically feasible and would violate certain standards governing right of access of persons with disabilities(PWDs).

Penalties set in violation of the ordinance will be: First Offense--fine of two thousand pesos(Php2,000); Second Offense--fine of three thousand pesos(Php3,000) and Third Offense-- fine of five thousand pesos(Php5,000) or imprisonment for a period not exceeding one(1) year, or both at the discretion of the court and suspension or non-issuance of the business permit. The ordinance will take effect 15 days after its approval after its publication in a newspaper of local circulation.

MISA DE GALLO RECOGNIZED BY VATICAN AS SIGNIFICANT TO THE CATHOLIC FAITH SAYS CEBU ARCHBISHOP PALMA AS POPE FRANCIS PRESIDED OVER FOR THE FIRST TIME

Cebu Archbishop Jose Palma said in his homily at the Carbon Market yesterday as the first day of the nine-day novena masses which leads to Christmas Day, " The Misa de Gallo is attractive, It is slowly being introduced by the Filipinos to the world." "The Vatican recognized the tradition of the Filipinos and acknowledges its significance in the Catholic Faith," the prelate added. This as the Vatican News said Pope Francis celebrated the "Simbang Gabi" on Sunday, December 15,at the St. Peter's Basilica for Rome's Filipino community as it is presided over for the first time by a Pope.

"Continue to be smugglers of faith", The Pope told the Filipinos in an impromptu remarks as He alluded on how overseas Filipinos "smuggle" their faith even to places where it is dangerous to be Catholic, such as in the Middle East.

Pope Francis said in his homily that while the Simbang Gabi has been held in the Philippines for centuries," In recent decades, thanks to Filipino migrants, this devotion has crossed national borders and arrived in many other countries." The Pope was referring to the exodus of more than 2 million Filipinos to other countries to provide a better life for their families.

Palma described as Pope Francis saw the beauty of this local tradition that is why he officiated the first mass as he said that "this reciprocity of the Vatican show's that the unique culture of faith of the Filipinos have inspired Catholics all over the world.

The Cebu prelate reminded the faithful that the celebration of Misa de Gallo is a preparation for the birth of Christ and likened the nine-day novena to the nine months the Virgin Mary carried Jesus in her womb.

"Padayon kita sa pag-sacrifice. Kita lang gyod magtaka sa opportunity to show the Lord nga malipayon kita sa pagalog sa Pasko," he urged. (Let us continue to sacrifice, Let us take this opportunity to show the Lord that we celebrate His birth.) And reiterated that the faithful to celebrate the Christmas season in a Christlike way---with joy, love and generosity.

Under Section 800 (g) of the CMTA, balikbayan boxes should only contain personal and household effects such as wearing apparel, personal adornments, electronic gadgets, toiletries to qualify for tax exemption. BOC seizes 20.80 kilos of Methamphetamine

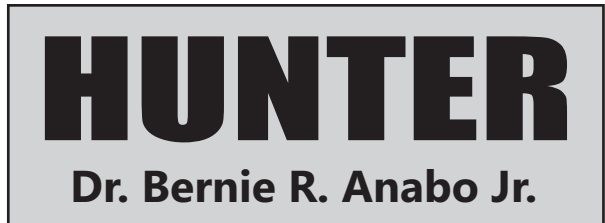
The Bureau of Customs (BOC) successfully intercepted 20.80 kilos shipment of methamphetamine, also known as "Shabu" at the FEDEX Warehouse in Pasay City. This illegal drugs shipment was presented at NAIA by BOC on December 18, 2019.

This illegal drugs shipment with an estimated street value of Php 141,440.00 million were declared as "Speakers" and shipped from the United States. The illegal drugs shipment was concealed in two parcels and discovered by BOC personnel when conducting the cargo examination process.

The seized drugs shall be turned over to the Philippine Drug Enforcement Agency (PDEA) for further investigation. The importation of dangerous drugs is a crime punishable under RA 9165 (Comprehensive Dangerous Drugs Act of 2002) in relation to RA 10863 (Customs Modernization Tariff Act).

The latest discovery of illegal drugs is the result of the continued efforts of the BOC in coordination with PDEA and other members of NAIA Inter-Agency Drug Interdiction Task Group (NAIA-ADITG). The Bureau of Customs (BOC) remains steadfast in implementing border security measures where apprehensions are the results of Bureau of Customs Commissioner Rey Leonardo B. Guerrero's directives to all Ports to be vigilant in the entry of illegal goods into the country.

BOC Clarification of Guidelines on Duty and Tax Free Balikbayan Boxes



The Bureau of Customs (BOC), on Wednesday, December 18, 2019, issued clarification guidelines on sending duty and tax-free balikbayan boxes. These guidelines identify the kind privileges available to all qualified Filipinos while abroad

Under Customs Modernization and Tariff Act (CMTA), Returning Residents, Overseas Filipino Workers (OFW), and other Filipinos while residing abroad or upon their return to the Philippines are allowed to bring in or send in duty and tax-free balikbayan boxes to their families or relatives. Qualified Filipinos While Abroad (QFWA) refers to OFWs with valid passports issued by the Department of Foreign Affairs (DFA) and certified by the Department of Labor and Employment (DOLE) or the Philippine Overseas Employment Administration (POEA) for overseas employment purposes. They cover all Filipinos, working in a foreign country under employment contracts, regardless of their professions, skills or employment status. It also includes Filipinos working abroad under job contracts that do not require certification from DOLE or POEA.

Resident Filipinos, on the other hand, refer to resident Filipino citizens who temporarily stay abroad which may include holders of a student visa, investor's visa, tourist visa and similar visas which allow them to establish temporary stay abroad.

It is allowed for Balikbayan boxes to be sent up to a maximum three (03) times in one calendar year provided that the total value shall not exceed P150,000.00. Any amount that exceeds the allowable value is subject to payment of duties and taxes. To qualify for the duty and tax-free privilege, the ultimate recipient or consignee of the balikbayan box must be family or relative up to the fourth civil

Barbara, Iloilo; Emilio Aguinaldo Shrine in Kawit, Cavite; Quince Martires monument, Naga City; Bonifacio Monument in Caloocan City; Vigan UNESCO World heritage in Vigan City, Ilocos Sur; Francisco Dagohoy monument in Danao, Bohol; Kenan Aman Dangat in Basco, Batanes; Sultan Kudarat monument in Cotabato City; Martyr of Bangkusay monument in Macabebe, Pampanga; Shiek Karimol Makhdum Mosque in Tubig Indangan, Bimumul, Tawi-Tawi; and Agusan Gold Image in Butuan City.

Different activities are slated by the committee on Quincentennial Commemoration aim to raise awareness and emphasize the Filipino-centric point of view in the historical narrative of the Battle of Mactan.

The public is encouraged to take part in the Quincentennial Commemorations events all over the Philippines which started December 2018 and will run until September 2022.

CEBU CUSTOMS SEIZES MISDECLARED RICE

Because of the Holiday season, some rice smugglers in Cebu are taking advantage on the demand of glutinous rice(super malagkit) as evident on Friday's issuance of the warrant of seizure and detention(WSD) order by Port of Cebu-Bureau of Customs(BOC) Acting District Collector Atty. Charlito Martin Mendoza.

Mendoza in his WSD order addressed to the District Commander of the Enforcement and Security Services-Customs Police Division(ESS-CPD),Port of Cebu, said " Whereas, during the examination, the assigned Customs Examiner N. Tan together with representatives from members from CREST, representatives from Bureau of Plant Industry(BPI), and Philippine Drug Enforcement Agency(PDEA) found that the shipment contained MISDECLARED GOODS, particularly 5x20 container vans containing Glutinous Rice."

He added that " based on the foregoing, the undersigned finds probable cause for the issuance of this warrant of seizure and detention against the entire shipment based on the violations of Section 1400 in relation to Section 1113(F.); Section 1113 (I); and Section 1113 (L-3,4,& 5) of Republic Act 10863 otherwise known as the Customs Modernization and Tariff Act(CMTA). Of the 10x20 footer container vans, the other five were ordinary rice with lesser customs duties and taxes.

Customs sources disclosed that a certain Chinese businessman identified only as "Vincent" wanted to slipped off paying about Php500,000 in duties and taxes, thus it was misdeclared. Based on official record of the shipment, it was consigned to SAGETICS ENTERPRISES with address at no. 33 Door 5 P. Gomez St. Centro, Mandaue City, Cebu with the Customs Broker identified as Mark Desabelle Cueva with address at Bausin St. Sitio Chava Atop Atop Bantayan island, Cebu and the rice came from Vietnam.

But Customs brokers' sources disclosed that Vincent has not notified Cueva that there were at least five container vans which contained glutinous rice.. The shipment will be subject to public auction.

BUREAU OF IMMIGRATION & QUEZON CITY POLICE DISTRICT ARREST 342 ILLEGAL ALLIENS IN QUEZON CITY



BAGO BANTAY, Quezon City—Operatives from the Bureau of Immigration (BI) arrested 342 illegal foreign nationals in a massive raid of an online gaming company yesterday evening. According to BI Commissioner Jaime Morente, the arrested were caught working without proper permits and visas at the 2nd, 3rd, and 4th Floors of the Global Trade Center Building in Bago Bantay, Quezon City.

The 342, all Chinese nationals, were reportedly working for a licensed Philippine Offshore Gaming Operator, who did not have the required permit to operate issued by the Philippine Amusement and Gaming Corporation (PAGCOR).

We sought the assistance of PAGCOR in confirming their permit, and we found out that the company was duly licensed, but was not yet allowed to operate," said Fortunato

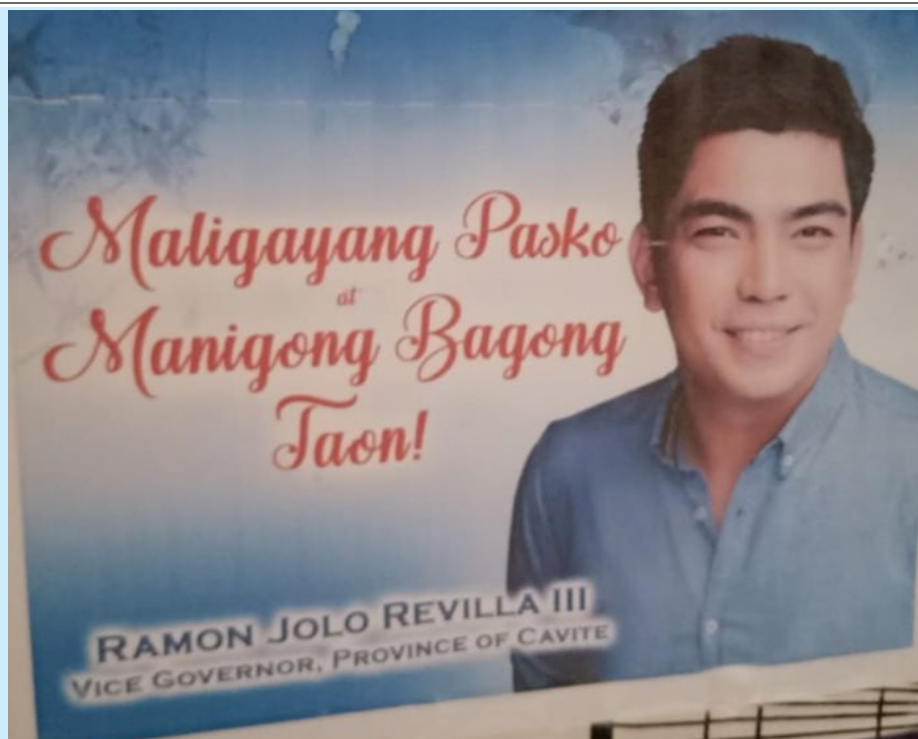
