@@@@@ Customs NAIA Intercepts Kush Weeds and Liquid Marijuana!

AS part of the Bureau of Customs [BOC] under the stewardship of Customs Commissioner Rey Leonardo B. Guerrero's mandate to protect the country's borders, the Port of Ninoy Aquino International Airport [NAIA] Customs Collector Mimel Talusan operatives intercepted Kush weeds and liquid marijuana with an estimated street value of P200,000 at the Central Mail Exchange Center (CMEC) in Pasay City.

The shipment was identified to have originated from California, USA and was declared as "one pair of shoes and chocolate". Upon examination, the parcel was found to contain four (4) packs of suspected kush weeds and ten (10) cartridges of liquid marijuana. The parcel was intercepted by alert Customs Operatives at NAIA in coordination with the Philippine Drug Enforcement Agency (PDEA) and NAIA Inter-Agency Drug Interdiction Task Group (NAIA-IADITG)

The Authorities suspected the presence of prohibited substances due to the scent emitted by the parcel. Previous apprehensions of marijuana were observed to have the same scent raising suspicion that the same was present in the parcel.

The alleged consignee who was identified as a certain Xavier Martin Bulos from Sampaloc, Manila was arrested while claiming the parcel and shall face charges for violation of RA 9165 also known as the Comprehensive Dangerous Drugs Act of 2002 in relation to RA 10863 or the Customs Modernization Tariff Act [CMTA].

BUREAU OF IMMIGRATION INTERCEPTS 3 WOMEN HIRED TO WORK AS BAR GIRLS IN HONGKONG



ureau of Immigration (BI) officers at the Ninoy Aquino International Airport (NAIA) have foiled another human trafficking attempt with the interception of three women who were illegally recruited to work as bar girls in Hongkong. The BI's travel control and enforcement unit (TCEU) said the passengers were intercepted Friday morning at the NAIA 1 terminal as they were about to board a Hongkong Airlines flight. They attempted to leave in the guise of being tourists but the immigration officers who processed them noted numerous inconsistencies in their statements, and referred them for

The trio initially presented fake tickets, as well as posed as employees of a travel agency, said the BI.

"It was during the interview that they admitted they

"It was during the interview that they admitted they were going to work in Hongkong and that they were promised salaries of 500 Hongkong dollars a day," said BI-TCEU head Ma. Timotea Barizo.

Barizo said women hired as club entertainers abroad are prone to become victims of human trafficking as there have been reports that many of them are eventually forced into prostitution.

"We have rescued these women from harm's way," Barizo added. It was learned that the women were recruited by a female agent whom they only met via Facebook. They admitted they each spent P15,000 for their plane tickets but the cost of processing their travel documents was shouldered by their recruiter whom they will pay through salary deduction.

"This is a trick being used by human traffickers," said Barizo. "Indebting victims for the cost of their recruitment essentially forces them into debt bondage. They have no choice but to work long hours, only to pay off their so-called debt," she added. The women were eventually turned over to the Inter-Agency Council Against Trafficking (IACAT) for assistance and further investigation.

DPWH BEGINS INVENTORY OF FOOTBRIDGES ALONG

NATIONAL ROADS

The Department of Public Works and Highways (DPWH) is now in the process of studying proposals for the possible inclusion of footbridges in its Annual Maintenance Program (AMWP).

In his report to DPWH Secretary Mark A. Villar, DPWH Bureau of Maintenance Director Ernesto G. Gregorio Jr. said that starting January 2020, all DPWH Regional and District Engineering Offices were required to submit an inventory of all footbridges along national roads, including structures' details and condition, and cost of repair.

"While the construction, repair and retrofitting of national roads and bridges is in our yearly program, we are receiving reports that the preservation of aging footbridges is being left out," said Director Gregorio.

"All structures built within the roads must be maintained to ensure safety of our motorists and pedestrians in cases of earthquakes and other calamities. Clearly there is a gap that needs to be addressed hence we are now looking into whether we can help the local government units (LGUs) and include the funding for the maintenance of degrading footbridges along national roads," explained Director Gregorio.

Currently, DPWH handles the design and construction
