@@@@@ PRC DONATES FACE MASKS TO BOC!

IN support to the Bureau of Customs' mandate on border protection, trade facilitation and revenue collection, the Bureau last, February 24, 2020 received 25,000 pieces of face masks donated by the Philippine Red Cross (PRC) led by PRC Chairman and CEO Senator Richard J. Gordon at the Philippine Red Cross headquarters at Mandaluyong city.

The face masks were received by the Commissioner Rey Leonardo B. Guerrero together with Public Information and Assistance Division Chief Bienvenido Datuin Jr. and General Services Division Chief Raquel De Jesus.

The donation was done amid the Coronavirus Disease-2019 (COVID-19) scare which has produced disruption in the global supply of face masks, gowns, gloves and other protective gear. Sen. Gordon said that the donation of 25,000 pieces of face masks is in line with his pronouncement that government front-liners should be given priority in the distribution of face masks and other protective gear because they come directly in contact with infected persons or possible carriers of the disease.

"We have to provide our front-liners with face masks and other protective gear. Our doctors, nurses, and other hospital personnel come in close contact with people infected with the novel coronavirus and patients under investigation. Likewise, the personnel of agencies like the Bureau of Immigration [BI], Bureau of Customs [BOC], airports and seaports and the Department of Foreign Affairs (DFA) also interact daily with inbound travellers, some of whom may be carriers of the disease. We should protect our front-liners and help prevent local transmission of COVID-19."

Commissioner Guerrero was very thankful for the donation and acknowledged the risks that BOC personnel face in the performance of their duty, but admitted his surprise that the PRC included the BOC among the beneficiaries of the face masks. "We did not expect to be included in the list of agencies that will be given face masks. But we are very, very grateful. We give our whole-hearted thanks to the noble cause of PRC and of course, to Sen. Gordon."

IN line with the Bureau of Customs' (BOC) drive to support Ease of Doing Business and instil good governance, the Bureau welcomed today February 26, 2020 Anti-Red Tape Authority (ARTA) Director General Jeremiah B. Belgica together with Deputy Director General Ernesto V. Perez and other service directors. On the part of the BOC, Commissioner Rey Leonardo B. Guerrero received the guests together with Assistant Commissioner Vincent Philip Maronilla, deputy commissioners and port collectors of POM, NAIA and MICP.

The visit started with a walk through on the newly created Customer Care Center where orientation was given on various services it provides. The group then proceeded at the Office of the Commissioner Conference Room where further details on the BOC CCC was presented by Public Information and Assistance Division Chief (PIAD) Bienvenido Datuin Jr. Also briefed was the 2019 BOC accomplishment report followed by an overview of the BOC Citizen's Charter Handbook by Atty. Marlon Fritz Broto from the Office of the Commissioner. This was followed by the formal turnover of the 2019 version of the handbook

In his message, Director General Belgica lauded the efforts of the BOC in pursuing change within the agency. The ARTA chief also praised the BOC in creating the CCC and for being one of the first government agencies to submit a Citizen's Charter Handbook. Belgica also touched on the efforts of ARTA in pursuing its mandate and explained the direction to which the Duterte government is headed in terms of trade facilitation and economic growth. He also highlighted the role of the Bureau in achieving such goals.

In his message Commissioner Rey Leonardo B. Guerrero thanked DG Belgica for visiting the Bureau. He recognized the efforts of ARTA to combat inter-agency red tape and acknowledged the challenges that the BOC faces in the implementation of reforms from within. ARTA Chief Lauds BOC for Efforts Against Red-tape!

THE Bureau of Customs (BOC) was recognized by the Anti-Red Tape Authority (ARTA) Director-General Jeremiah B. Belgica during his visit to the BOC yesterday, February 26, 2020, for its efforts to simplify frontline processes, automate systems and implement a zero-contact policy in compliance with ARTA's thrust to reduce red tape and expedite government processes.

The ARTA chief also praised the Bureau for being one of the first agencies to comply with ARTA's requirement to produce a citizen's charter handbook. "You are a beacon of light to the BOC" stated Belgica to Commissioner Rey Leonardo B. Guerrero as he delivered his message thanking the BOC for the accommodation extended to the ARTA delegation.

DG Belgica further stressed the importance of interagency cooperation in achieving true change. He also added that the BOC was not part of the top 5 agencies to which ARTA is focused on and that indeed the current BOC administration is doing well. "The BOC has been a great partner not only by the ARTA but also in the reforms that our President has been really pushing for," Belgica added.

Recently, the Bureau issued a memorandum in compliance to ARTA Memorandum Circular No. 2020-02, directing BOC offices to conduct and submit on or before March 2, 2020 an inventory of all pending simple, complex and highly-technical transactions as of February 14, 2020, as well as those which are not acted upon beyond the prescribed processing time in accordance with the updated Citizen's Charter, and to issue/release the application or request as automatically approved or automatically extended, as the case may be.

For his part, BOC Com.Guerrero thanked DG Belgica and ARTA for their visit and committed better coordination to further improve services and trade facilitation. "Rest assured that the BOC will work closely with ARTA in achieving effective and lasting reforms."

CEBU HOSTS ASEAN CUSTOMS ENFORCEMENT INITIATIVES AS IT WANT IT STRENGTHENED IN THE REGION

 SouthEast Asian Nations (ASEAN) yesterday vowed to strengthen its regional cooperation and intensified coordination in implementing trade facilitation and customs law.

The Bureau of Customs (BOC) of the Port of Cebu hosted the 3-day conference attended by the Finance and Customs officials from Cambodia, Indonesia, Lao PDR, Myanmar, Vietnam, Philippines, Singapore, Thailand, Malaysia including Australian Border Force, Intellectual Property Office of the Philippines (POPHIL) and Japan Ministry of Finance. Cebu Customs District Collector Atty. Charlito Mendoza emphasized that the cooperation goes beyond both ways-- on one hand, by sharing with the ASEAN neighbors each nation's customs best practices and on the other hand, by helping to address areas needed support and assistance."

"Our Unity is our strongest assault and defines against any threat new or old--- to customs compliance and enforcement," he said during the opening ceremonies. Discussed were different concerns but highlighted is the regional campaign against illegal drugs.

This is the first time Cebu to host this ASEAN Customs Enforcement and Compliance Working Group (CECWG) and this was its 27th conference as it is being rotated in the nine-member ASEAN countries on an annual basis.

Mendoza believes that guided by the relevant international and regional programs, the CECWG meeting is directed to the adoption and implementation of measures of customs enforcement and promoting of voluntary compliance with the view to safeguard customs revenues and contribute to trade and investment.

DOH-7 Regional Director Dr. Jaime Bernadas told media that :most of the 26 are staying in hotels,12 in Lapu-Lapu City and 14 in Cebu City.."

"If they are found out to be symptomatic, then they will be classified as Persons Under Investigation(PUIs) and should be admitted to hospitals," he added

"They (26 Koreans) were contacted already and were advised to stay in their respective accommodations and will be subjected for close monitoring," Dr, Terence Bermejo,the chief of the BOQ. This as Cebu Governor Gwendolyn Garcia yesterday signed Executive Order No. 5-A extending the travel ban from Daegu City.

She added that same quarantine protocols imposed on travellers from China will be done on Daegu City passengers. Daegu City is the epicenter of the Coronavirus(COVID!) outbreak in South Korea and there are 22 direct flights weekly from CEbu to Daegu.

The Bureau of Immigration recorded that in 2019 alone there were 860,087 arriving Koreans at the Mactan Cebu International Airport(MCIA) with 859,643 departing from Mactan.



Popular Myths About Success that Need to Be Ignored

ow often has this happened to you? ... You want to do more with your life – get into great shape, pursue a hobby you're passionate about, start your own business, or work toward a new career, etc. You start building a positive habit that will take

you in that direction - exercise, waking up early, writing, meditation, an evening routine, studying, etc.

You begin with a lot of determination (for a week maybe) Then something makes you skip your habit for a couple of days: a new project at work, unexpected household events, illness, family coming to visit, and so on.

Those "busy" days keep popping up, and so you skip more often. Before long, you abandon your new habit altogether.

It's frustrating isn't it? Trying again and again to build positive habits, but not being able to? Sometimes you feel that you simply don't have it in you to do anything anymore. You are just too busy, too old, and just plain exhausted.

But what if that's not true? What if the only things holding you back are a few limiting beliefs? And I'm not talking about negative beliefs. We hold numerous beliefs about what works, about the correct way to do things, and about what we need to do to be successful. And on the surface, many of these beliefs sound quite positive and motivational, and they are in some situations. However, in many other situations, they turn into motivational myths that completely cripple our progress and prevent us from building positive

habits. Let us discuss these myths:

Myth #1: All you need to do is work really, really hard to be successful. This belief is single-handedly responsible for at least half of all the personal failures people have discussed with me over the

years. This might sound ridiculous, but it's true!

After all, everyone agrees that success requires hard work, regardless of whether you want to run a marathon or build a successful business. Simply put, hard work is something you just can't avoid, even if you work smart.

However, you also likely have other job responsibilities household chores, and family responsibilities. Where do you find the time and energy to work hard on new positive habits every day? For instance, you might be trying to build a habit of exercising for 30 minutes every day. But what about those days when you don't have

30 minutes? You skip, and then you keep on skipping.

The good news is that hard work is NOT the most important element in success, at least not initially, when you are just beginning to build a habit. The only thing that matters initially is to actually do the habit every day for a very short time. Therefore, rather than try to exercise for 30 minutes a day, start with as little as two minutes a day.

You may be wondering – two minutes a day will clearly not help you achieve any results at all, so what's the point? The point is simply to become accustomed to an everyday routine. A habit is something that you do without willpower, something that comes to you naturally. Doing it every day trains a part of your brain - the cingulate gyrus – to ingrain this activity and make it as natural as brushing your teeth every morning.

Within a couple of weeks, your brain will get used to the

process of doing the activity every day at a specific time or place. That's when you can increase the time by two to five minutes every week. Taking it slow allows you to make gradual adaptations to you everyday routine to accommodate your new habit. Within a few weeks, you will reach your 30-minute target, and it will have become a habit for life that doesn't feel like a burden.

The key: Just remember, hard work is important, but that's the second step toward change. The first step is consistency. Once you become consistent with a small habit, only then should you begin to work harder at it.

Myth #2: You must have a hard deadline, and if you don't hit it you will fail. Are you trying to build new habits to reach certain goals by a set deadline?

goals by a set deadline?

Something like, "I have to lose 10 pounds in one month," or, "I have to become a published author within a year." You might believe that you can't get anything done without setting deadlines. But what if I told you that deadlines are actually holding you back in many cases? This happens in two ways:

First, a deadline will draw your attention toward your goal, the result that you seek. You will constantly evaluate how well you did every day by checking your weight or critically judging the quality of

your writing. What you haven't taken into account is that during the first few weeks, you might not gain any visible results at all. You might struggle to run even for half a mile or write anything meaningful. That's all part of the natural skill development process that everyone goes through. This lack of visible progress can really discourage you. You might feel that you just don't have what it takes, and you may be motivated to abandon your goal altogether.

Deadlines also cause people to underestimate the amount of time required to get a job done. Look around and you will see this happening in all walks of life. People often miss deadlines at the workplace or end up putting in extra hours at the last minute. If you set deadlines that are not practical, you are building up unrealistic expectations that will soon demotivate you.

It's important to understand that deadlines have a time and a place, but they aren't universally beneficial. For instance, do hard deadlines truly matter for building long-term, life-changing habits? No, they don't. Even if you take 10 years to become a published author or set up your own business, imagine the impact that will have on the rest of your life. What's the big hurry? Take it slow and steady... small, consistent steps forward every day.

The key: Especially during the first few weeks, forget about setting rigid deadlines and just focus on what's important - building the setting rigid deadlines and just rocus on what s important – building the foundation for your positive habit or routine. If you need a better approach to stay motivated, focus on your "big why." Why do you want to build this habit/project/etc.? What rewards will you gain? How will it make you happier and more fulfilled? Write this down, remember it, and let it be your inspiration!

Myth #3: You have to be bigger and better than you are right Goals are important. All journeys of change must begin with a goal. You also must have determination in order to achieve those goals. However, what do you think happens when you are too determined? You begin to nurture another belief: who you are right now is not good enough. You have to accept yourself as you are, and then commit to personal growth. If you think you are absolutely "perfect" already, you will not make any positive efforts to grow. But constantly criticizing yourself is just as counterproductive as doing nothing, because you will never be able to build new positive habits when you're obsessively focused on your flaws.

The key: Follow the middle path. Change your mantra from, "I have to be better," to, "I will do my absolute best today." The second mantra is far more effective because it actually prompts you to take positive action every day while simultaneously accepting the reality that every effort may not be perfect. Remember: You already are good enough; you just need more practice.

Myth #4: You must be willing to sacrifice everything to be successful. You've heard this story a million times: successful people work for hours without taking breaks, eating, or sleeping.

Many people try to find more time for their positive habits

and projects by skipping breakfast, sleeping less than even six hours, or hardly taking any breaks at work. Such drastic measures are scientifically known to be sure-fire ways of reducing your productivity.
They diminish your energy, IQ, decision-making ability, willpower and more. Sooner or later, sacrificing adequate food or sleep will become too troublesome to sustain, and you will end up quitting too soon.

The key: Rather than try to gain time through over-the-top sacrifices, why not spend less time on things that matter less? Spend less time on social media, less time watching TV, or fewer evenings at the pub.

Myth #5: You can (and should) completely transform yourself all at once. Do you have a future image of yourself as a transformed person? Someone who is healthier, happier, more confident, incredibly productive, always able to balance work and life, and so on. Most of us do to a certain extent. Every now and then, we become motivated to do something to become that person. The most common example of this is during New Year celebrations when we make resolutions with a remarkable amount of optimism. Anything seems possible in the New Year! You kick off with tremendous motivation: "Yes, this time, it's going to be different!" But you know how it usually goes. Resolutions just remain... well, resolutions and wishes for some other time.

Your over-enthusiasm is actually the cause of your failure. When you try to build six new habits at a time, or even two, you will become overwhelmed and most likely fail at every habit.

Why? Because making changes requires willpower. Trying

estor

to build two new habits at the same time divides your available will power between those two pursuits, making it more difficult for you to do either

The key: Successful transformation begins with building a single habit, preferably the simplest one first. Don't begin the second habit until you have been consistently doing the first one for at least a month. Let your first victory pave the way for your second.

Closing Thoughts: You may have failed at building positive

habits and changes into your life multiple times in the past. That doesn't mean you are too busy, undisciplined, or lazy. You were only harboring some beliefs that were holding you back. Once you free yourself from the deceptive grip of these beliefs, you'll see the difference. It's time to get back into the game. Take the first step today!

ROAD IMPROVEMENT PROJECTS ALONG MANILA-**BATANGAS ROAD COMPLETED**

The Department of Public Works and Highways (DPWH) has widened and improved portions of the existing Manila-Batangas Road in Barangays Concepcion, Mahabang Parang, Kumintang Ibaba, Kumintang Ilaya, and Balagtas in the City of Batangas.

District Engineer Sonia D. Paglicauan of DPWH Batangas 2nd District Engineering Office (DEO) reported the recent completion of two (2) road improvement projects that are seen to improve vehicular movement in Batangas City during rush

Through these projects, a total of 2.08-kilometer portion of Manila-Batangas Road in Barangay Concepcion and Mahabang Parang have an off-carriageway, road shoulder and closed canal; 913 meters of the road in Barangays Kumintang Ibaba and Kumintang Ilaya and 251 meters in Barangay Balagtas have also been widened, with road shoulder and drainage component," said District Engineer Paglicauan.

Duterte said he was leaving the ABS-CBN franchise issue to Congress. "I leave it to Congress... The critical move is in the House and I tell you I am not going to interfere," the President said.

Duterte, who has previously threatened to block the ABS-CBN franchise renewal, however noted that he did not speak to any lawmaker regarding the network's license to operate which expires in May. Duterte however did not give a categorical answer when asked if he would sign into law the bill granting ABS-CBN a fresh 25-year license to operate in the event that the proposal hurdles Congress.

"I will cross the bridge when I get there. Maybe I will call the media to help me out. It would be a difficult decision, really. So I will... I

will cross the bridge when I get there," he said.

As to Solicitor General Jose Calida's move to invalidate ABS-CBN's existing franchise via a "quo warranto" petition, Duterte said he cannot do anything about it because the government's top lawver does not report to him. Calida earlier this month asked the Supreme Court to revoke ABS-CBN's franchise due to alleged "abuses" like pay-per-view (PPV) operation and violation of the constitutional ban against foreign ownership.

The government's top lawyer also sought a gag order

against the network, alleging that ABS-CBN "engaged in propaganda." But Duterte said SolGen works on his own. "The SolGen does not clear with me unlike the Secretary of Justice. He will call my attention or he will bring it up in the Cabinet. Ang

Pursuant to Ordinance No. 19-32, Series of 2019 entitled AN ORDINANCE GRANTING FINANCIAL RELIEF OR TAX AMNESTY TO OWNERS OF REAL PROPERTY FROM PAYMENT SURCHARGES AND PENALTIES FOR A LIMITED PERIOD OF TIME IN THE CITY OF PARA-NAQUE, the City Government of Parañaque grants tax reliefs for real properties (land, improvements and machinery) delinquent in the payment of real property tax.

The salient provisions of the said ordinance are:

- 1. The tax amnesty shall be from January 01, 2020 up to March 31, 2020 only.
- 2. Payment by cash or manager's check only. Personal or company check shall not be accepted.
- 3. Covers delinquent real properties and idle lands whose owners failed to pay tax due for the last five years shall be exempted from payment of surcharge and penalties.
- 4. Covers real properties declared for the first time and assessed for ten (10) years. Real Property Tax is reduced to five (5) years.
- 5. Covers those reclassified from residential to commercial/industrial from 2014 up to present shall also be exempted from paying interest/surcharge.
- 6. To avail of the real property tax amnesty, owners must pay the delinquency including the tax due on said property for the first quarter of calendar year 2020 during the amnesty period from January 01, 2020 up to March 31, 2020 only.
- 7. If the owners elect to pay the delinquency including the tax due on said property for the entire year 2020 during the amnesty period from January 01, 2020 up to March 31, 2020 said payment shall also be entitled to the discount for prompt payment as provided under the Revenue Code of Parañaque.
- 8. Not covered by the amnesty are delinquent properties sold to public auction; real properties subject to expropriation; and real property under compromise agreement pursuant to existing ordinances.
