BOC Monitors Influx of Foreign Currencies!

IN its bid to combat illicit financial flows and to protect the interest of the general public, the Bureau of Customs (BOC) under the stewardship of Customs Commissioner Rey Leonardo B. Guerrero has heightened its efforts to address influx of suspicious large amounts of foreign currency into the country.

Several groups of passenger-couriers declaring huge amount of foreign currency have been identified by the BOC through its sustained monitoring efforts.

The BOC reported that it is addressing the matter and has already been working silently with the Anti-Money Laundering Council (AMLC), Bangko Sentral ng Pilipinas (BSP) and other intelligence and law enforcement agencies including Congress.

Under existing laws, amounts of foreign currency exceeding \$10,000.00 in value are allowed to be brought into the country for as long as it is declared.

The Bureau of Customs vows to continuously intensify its efforts on border protection and prevent the illegal movements of illicit money or capital to and from the Philippines.

Strengthening Regional Customs Enforcement: BOC Hosts the 27th Meeting of the ASEAN CECWG!

IN line with the commitment of Association of South East Asian Nations (ASEAN) to pursue regional trade facilitation, the ASEAN Customs Enforcement and Compliance Working Group (CECWG) held its 27th Meeting in Cebu, Philippines on February 25-27, 2020.

The three-day meeting was presided by Chairman Sazali Mohamad, State Deputy Director of Customs of the Royal Malaysian Customs Department and attended by the delegates from ASEAN member-states - Cambodia, Indonesia, Lao PDR, Malaysia, Myanmar, Philippines, Singapore, Thailand, and Vietnam, including representatives from Australian Border Force, Intellectual Property Office Philippines (IPOPHL), and Japan Ministry of Finance.

In his opening remarks delivered on 25 February 2020, Atty. CHARLITO MARTIN R. MENDOZA, Acting District Collector, Port of Cebu, emphasized that the regional cooperation goes both ways—"on one hand, by showing and sharing to our neighbors where we are strong and effective and how our best practices may be used by others and, on the other hand, it is also showing and sharing where we are struggling, where we may be inefficient, where compliance is low, where we need support and assistance from our neighbors. Our unity is our strongest assault and defense against any threat- new or old- to customs compliance and enforcement". Echoing the same confidence, Chairman Sazali Mohamad commended the CECWG as the best platform to promote regional customs enforcement and compliance efforts among the ASEAN nations. He highlighted significant progresses achieved by the CECWG over the past two years despite the roadblocks in the implementation.

The CECWG Meeting commenced on the review on the works undertaken from the decisions of the previous 26th CECWG Meeting held in Bali, Indonesia. Delegates presented to CECWG the efforts adopted by each member-states on customs

development, enforcement, mutual assistance, including regional public security and protection of the society.

Among the topics of significant interest are issues relating to intellectual property rights [IPR] and transboundary waste. Atty. Theodoro Pascua and Atty. Marlita Dagsa from Intellectual Property Office-Philippines who represented ASEAN Network of IP Enforcement Experts (ANIEE) briefed the CECWG on some initiatives handled by ANIEE which include anti-piracy information campaigns and collation of IP-related cases for statistical data and analysis. Atty. Pascua and Dagsa extended the interest of ANIEE for deeper cooperation with the CECWG on customs enforcement relating to intellectual property violations.

The CECWG also noted issues pertaining to activities aimed at combating transboundary disposal of plastic waste. The delegates acknowledged the procedural and practical aspects revolving around the issue considering that this involves not only customs administration but also cross-border crimes and activities. The CECWG was in consensus to tackle the topic further and emphasized the need for collaboration with other ASEAN bodies to explore the issues involved.

The Australian Border Force presented a concept on real-time intelligence and information sharing on tobacco movement. The delegates supported the concept and proposed that the model of operations be consistent with the member-states domestic laws and regulations.

Japan Ministry of Finance, on the other hand, promoted cooperation to battle dangerous drugs smuggling. The CECWG aspired for joint workshops with Japan to discuss the enforcement area on the regional anti-drug smuggling campaign. Deputy Commissioner Teddy Raval of the Enforcement Group [ED] led the closing ceremony marking the conclusion of the successful 27th Meeting of the ASEAN CECWG. In his remarks, he applauded the works of the CECWG whose labors benefit the member-states beyond borders.

Despite challenges brought about by borderless economy, Deputy Commissioner Raval pointed out that "(t)he real issue before us is not the debate about our differences but to see how technological process can be better channelled to promote growth and more trade and in the process help our nations and its neighbors to remerge."

The ASEAN Secretariat and the delegates expressed their appreciation to the Bureau of Customs Philippines for the hospitality and excellent arrangements made for the Meeting.

BOC-NAIA Intercept P1.1-M from Malaysian Passenger!

THE Bureau of Customs [BOC] Port of NAIA intercepted P1.1 Million Philippine Pesos from a passenger from Kota Kinabalu who arrived via AirAsia Flight No. Z2 502 on March 6, 2020 at around 9:00pm at the Ninoy Aquino International Airport (NAIA) Terminal 3.

The Philippine currency was seized for violation of Republic Act No. 10863 Customs Modernization and Tariff Act [CMTA] in relation to Bangko Sentral ng Pilipinas (BSP) Circular No. 922 s.2016 on Cross-Border Transfer of Local and Foreign Currencies.

The incident started when the duty Customs Examiner noticed a passenger and his two companions acting suspiciously. He then directed the passenger identified thru his Malaysian passport as GAN KANG HSIUNG, male, 32 years old, to bring his checked-in baggage to the Customs examination lane.

The Customs Intelligence and Investigation Service (CIIS) and Enforcement and Security Service (ESS) operatives assisted the Examiner in undertaking the examination. Initial results yielded bundles of Philippine peso bills.

The importation or exportation of Philippine currency is regulated under the BSP Advisory on Cross-Border Transfer of Local and Foreign Currencies, wherein a person may bring in and out of the Philippines not more than P50,000.00. Any amount exceeding P50,000.00 will require authorization from the Bangko Sentral ng Pilipinas (BSP) prior to importation or exportation.



One Simple Phrase that Will Change Your Thoughts

As human beings, the stories we subconsciously tell ourselves about our circumstances, about others, and about life in general drastically changes how we feel. If the stories are positive, we tend to feel good. If the stories are negative, we tend to lose hope. Of course, there's more to feeling good than just being positive. The details of your present reality matter and make a difference, but generally speaking, you're not going to have a good day today if you're hell-bent on telling yourself otherwise.

The stories we tell ourselves don't just change how we feel – they actually change what we see, what we experience, and what we know to be true. This is one of the primary reasons multiple people can go through the same experience, but interpret it differently. Each of us may enter a shared experience with a different story echoing through our mind, and our unique story – our inner dialog – alters the way we feel every step of the way, and so each of us exits this shared experience with a slightly different feeling about what just happened. And sometimes that slight difference makes all the difference in the world. If we want

to get on the same page with one another, and garner a better understanding of reality, we have to do a little work.

Perspective is Everything

In a way, the stories we tell ourselves narrow our perspective. When we enter an experience with a story about how life is, that tends to be all we see. This phenomenon reminds me of an old parable in which a group of blind men touch an elephant for the very first time to learn what it's like. Each one of them feels a different part of the elephant, but only that one part, such as the leg, trunk, side, or tusk. Then the men eagerly compare notes and quickly learn that they are in complete disagreement about what an elephant looks like.

Something similar happens through our wide-ranging, different past experiences. Some of us have been deeply heartbroken. Some of us have lost our parents, siblings or children to accidents and illnesses. Some of us have dealt with infidelity. Some of us have been fired from jobs we relied on. Some of us have been discriminated against because of our gender or race. And when we enter a new experience that arouses prominent memories of our own painful story from the past, it shifts our



perspective in the present – it narrows it.

When a negative past experience narrows our present perspective, it's mostly just a defense mechanism. Every day of our lives we are presented with some level of uncertainty, and our innate human defense mechanisms don't like this one bit. So our minds try to compensate by filling in the gaps of information by clinging to the stories we already feel comfortable with. We end up subconsciously trying to make better sense of everything in the present by using old stories and past experiences as filler. And while this approach works sometimes, other times our old stories and past experiences are completely irrelevant to the present moment, so they end up hurting us far more than they help.

CEBU'S HOTELS/RESORTS DOWN ON IT OCCUPANCY RATES AS GWEN SUGGESTED REDUCE RATES AND INVITE LOCAL TOURISTS

Aside from Mactan Cebu International Airport(MCIA) and the Cebu International Port(CIP), hotels and resorts in Cebu Province has complained on its low occupancy rates because of the 2019 Coronavirus disease (COVID19).

This concern was expressed by officers of the Hotels, Resorts, Restaurants Association of Cebu(HRRAC), who attended the Tourism stakeholders meeting presided over by Cebu Governor Gwendolyn Garcia.

HRRAC officer during the meeting disclosed that the occupancy rate of hotels and resorts as of this time has drastically decreased to 10% -25% compared in previous months of 75%-85%.

DAILY TRIBUNE tried to confirm from HRRAC President Carlo Suarez on such complained but as of this writing, he has not yet replied.

This made Garcia to suggest that the tourism sector now have to encourage local tourists to visit Cebu.

"One suggestion is for hotels and resorts to reduce their rates or introduce promo rates that can invite our local tourists from Cebu, Luzon, Visayas and Mindanao."

There are about 10,600 (3-5 star) hotels and resorts in Cebu province and many of these are in the cities of Cebu, Mandaue and Lapu-Lapu.

In Cebu City hotels and resorts, the average room rates are Php1,490-Php6,660 while Mandaue has Php1,490-Php6,270 and Lapu-Lapu City ranges from Php 3,340-Php12,130.

Cebu is seeing 83%-85% occupancy rates with branded hotels operating at 90% occupancy but with the COVID19 and suspension of international flights from China and Daegu City, South Korea, hotel guests has drastically decreased.

More than half of hotel room supply is in Cebu City while 30% in Lapu-Lapu City. The 3-star category is at 38% while the 4-star has 27%.

MARINA SUSPENDS OPERATION OF MV MIRA AS OTHER VESSELS OF JOMALIA SHIPPING TO BE RE-INSPECTED

The Maritime Industry Authority(MARINA) in Central Visayas yesterday ordered the suspension of operations of vessel MV Mika Mari III which was rescued on Monday with 133 passengers and 17 crew members with 16 rolling cargoes off shore of Consuelo port in Poro, Camotes Island, Cebu.

Engr. Marc Anthony Pascua, MARINA-7 Regional Director said "With the past maritime incidents involving the ships of Jomalia Shipping Corporation(JOMALIA) and the recent maritime incident on 02 March involving its ship named MV MIKA MARI III plying the Danao City-Consuelo, Camotes and vice versa route, MARINA has undertaken concrete measures which are aimed at preventing the lives of their passengers and crew from undue risks. These courses of actions are as follows: 1.) Order of immediate suspension of operation of the ship MV "MIKA MARI III". 2.) Issuance of Show Cause Order against the Master and Chief Engineer of MV "MIKA MARI III." 3.) Conduct of Re-inspection and additional Shipboard Audit on all of JOMALIA's operating ships."

"Safety certificates are suspended po, ma lift lang po siya kung makapasa siya sa safety rules after re-inspection. Other fleets will be subjected to ISM Audits po," Pascua said in his text message to DAILY TRIBUNE. "At the outset, it must be stressed that MARINA is committed to effectively carry out its mandate to enforce compliance with safety standards as well as to enforce such rules and regulations which will ensure compliance by every domestic ship operator with the required safety standards on vessel safety," he added.

MV Mika Mari III had overheated engine trouble on Monday while the vessel was 2 nautical miles going to Consuelo port in Poro town in Camotes Island from Danao City port which left 2:30pm. Philippine Coast Guard(PCG)-Consuelo station received a distressed call at about 4:55 pm.

NAIA CUSTOMS INTERCEPTS BULK PHILIPPINE CURRENCY

AIA Customs intercepted 1.1 Million Philippine Pesos from a passenger from Kota Kinabalu who arrived via AirAsia Flight No. Z2 502 on March 6, 2020 at around 9:00pm at NAIA Terminal 3.

The Philippine currencies were seized for violation of R.A. 10863 (Customs Modernization and Tariff Act) in relation to Bangko Sentral ng Pilipinas (BSP) Circular No. 922 s.2016 on Cross-Border Transfer of Local and Foreign Currencies.

A Customs Examiner observed that the passenger and his two companions were acting suspiciously so he directed the passenger who was identified thru his Malaysian passport as GAN KANG HSIUNG, male, 32 years old, to bring his checked-in baggage



to the Customs examination lane. CIIS and ESS operatives assisted the Examiner.

Initial examination conducted by the Customs Examiner yielded bundles of Philippine peso bills.

The importation or exportation of Philippine currency is regulated. Under the BSP Advisory on Cross-Border Transfer of Local and Foreign Currencies, a person may freely bring in and out of the Philippines not more than Php 50,000.00. Any amount exceeding Php 50,000.00 will require authorization from the Bangko Sentral ng Pilipinas (BSP) prior to importation or exportation.

The passenger is presently under custodial investigation by the Customs Enforcement and Security Service to determine whether inquest proceedings for smuggling will be instituted.

CITY ORDINANCE NO.19-32, Series of 2019


**JANUARY 01, 2020 up to
MARCH 31, 2020**

Pursuant to Ordinance No. 19-32, Series of 2019 entitled AN ORDINANCE GRANTING FINANCIAL RELIEF OR TAX AMNESTY TO OWNERS OF REAL PROPERTY FROM PAYMENT SURCHARGES AND PENALTIES FOR A LIMITED PERIOD OF TIME IN THE CITY OF PARAÑAQUE, the City Government of Parañaque grants tax reliefs for real properties (land, improvements and machinery) delinquent in the payment of real property tax.

The salient provisions of the said ordinance are:

1. The tax amnesty shall be from January 01, 2020 up to March 31, 2020 only.
2. Payment by cash or manager's check only. *Personal or company check shall not be accepted.*
3. Covers delinquent real properties and idle lands whose owners failed to pay tax due for the last five years shall be exempted from payment of surcharge and penalties.
4. Covers real properties declared for the first time and assessed for ten (10) years.
Real Property Tax is reduced to five (5) years.
5. Covers those reclassified from residential to commercial/industrial from 2014 up to present shall also be exempted from paying interest/surcharge.
6. To avail of the real property tax amnesty, owners must pay the delinquency including the tax due on said property for the first quarter of calendar year 2020 during the amnesty period from January 01, 2020 up to March 31, 2020 only.
7. If the owners elect to pay the delinquency including the tax due on said property for the entire year 2020 during the amnesty period from January 01, 2020 up to March 31, 2020 said payment shall also be entitled to the discount for prompt payment as provided under the Revenue Code of Parañaque.
8. Not covered by the amnesty are delinquent properties sold to public auction; real properties subject to expropriation; and real property under compromise agreement pursuant to existing ordinances.
