Liquor ban in Cavite lifted beginning June 1. Karaoke? Still a 'No'

The province-wide prohibition of alcoholic drinks in Cavite will be lifted beginning June 1, Governor Jonvic Remulla announced on Friday. "Effective June 1, the liquor ban is officially lifted," Remulla said in a Facebook post.

Local health board conducts online meeting

Distribution of P2000 Carmona LGU cash assistance for locals continues



On May 29, 2020, the local government of Carmona continued to distribute cash subsidy worth Php 2,000.00 at Barangay Bancal through the Carmona COVID-19 Assistance Program (CCAP) for the second batch of citizens who were not able to receive any financial assistance from the national government such as DSWD's Social Amelioration Program.

Remulla said only quarantine pass holders can buy liquor from stores. Selling of the product is allowed only from 1 p.m. to 4 p.m. daily.

However, liquor consumption in public remains prohibited.

"Bawal ang inuman sa labas ng bahayan o plain sight ng persons of authority.

Huwag na naman sabihin na 'Bahay ko, pwede ko gawin ang gusto ko.' Pag sa loob ng bahay ay wala kaming pakialam. Huwag lamang in public view," said Remulla.

(Drinking session is not allowed outside the house or in plain sight of persons of authority. Don't tell us you can do whatever you want in your houses. We don't care if you

drink inside your homes. Just don't do it in public view.)

At the same time, karaoke in public and mass gatherings are still not allowed in the province, where general community quarantine (GCQ) has been enforced since May 16.

Curfew hours will remain in effect from 8 p.m. to 5 a.m., according to Remulla.

IG-DepCom. Ramiro and CIIS-103 Enciso Seized P50M Worth of Overpriced Medical Supplies!

ALMOST P50 million worth of Medical Supplies and Equipments were seized on May 28, 2020 by the authorities of the Bureau of Customs [BOC] under the stewardship of Customs Commissioner Rey Leonardo B. Guerrero and IG-Deputy Commissioner Raniel Ramiro in a warehouse owned by Omnibus Biomedical System, Inc., which was recently tagged in a Senate inquiry for selling overpriced automatic extraction machines to the government.

The bureau said the company has been under investigation for alleged smuggling

Zambo Coll. Barte Destroys P245.8 Million Worth of Smuggled Cigarettes!

THE Bureau of Customs [BOC] under the stewardship of Customs Commissioner Rey Leonardo B. Guerrero the Port of Zamboanga [POZ] District Collector Segundo Sigmundfreud Z. Barte JR. has destroyed at least P245.8 million worth of smuggled cigarettes on May 5, 2020 at Fast Cargo Logistics Baliwasan, Zamboanga City.

District Coll. Barte Jr. who led the destruction of the smuggled cigarettes was assisted by the CIIS, ESS and representatives from the Philippine Navy, Philippine Marines (MBLT-11), Philippine Coast Guard, Naval Intelligence Support Group, PNP Zamboanga City, Philippine Ports Authority, National Bureau of Investigation, PNP-Criminal Investigation and Detection Group, Bureau of Fire and Protection, PNP Maritime Group and

IG-DepCom. Ramiro, IO3 Enciso & NBI Seizes P40-M worth of Chinese Medicines!

ALMOST P40 million worth of Chinese medicines alleged to be a cure against the Corona-virus 2019 (COVID-19) not cleared with the Food and Drug Administration (FDA), Personal Protective Equipment (PPE) and medical supplies were seized by joint operatives from the Bureau of Customs (BOC) under the stewardship of Customs Commissioner Rey Leonardo B. Guerrero with the Intelligence Group [IG] Deputy Commissioner Raniel Ramiro and the National Bureau of Investigation (NBI) in a warehouse in Manila on May 01, 2020.

At around 10:45 am May 01, 2020, operatives from the BOC's Intelligence Group-Customs Intelligence Investigation Service (IG-CIIS) Team Leader IO3 Alvin Y. Enciso, Enforcement and Security Service (ESS), NBI-Special Action Unit (SAU) backed up by personnel of the Philippine Coast Guard (PCG) raided the warehouse located in Singalong, Malate, Manila City.

The combined operatives served a Letter of Authority (LOA) received by a Chinese national representative of the warehouse. Among those found were boxes containing PPE, surgical masks, medicines and other medical supplies.

The BOC -IG DepCom. Ramiro said "There will be no let up in our anti-smuggling campaign despite the threat of COVID-19 in the country. Our men will continue to be diligent in fulfilling the mission and get the job done." The BOC further assures the public that it will continue to be at the forefront of the government's campaign against unscrupulous businessmen taking advantage of the high demand for PPE and medical supplies and the increasing number of people in search for medicines that could cure patients infected by COVID 19.

The warehouse representative was invited to appear before the NBI to explain the presence of the unauthorised Chinese medicines, PPE and medical supplies inside the warehouse. The authorities would also determine if these items were smuggled into the country, and if these are illegally being sold to the public.

The Customs examiners are currently conducting an inventory of the goods discovered inside the warehouse. Representatives from the IG-CIIS IO3 Enciso, BOC Enforcement and Security Service (ESS), PCG and NBI are also at the warehouse to witness the inventory.

BOC-IG Monitors Illegal Traders of PPEs and Medical Supplies!

THE country battles the deadly Novel Corona-virus (COVID-19), the Bureau of Customs (BOC)-Intelligence Group (IG) Deputy Commissioner Raniel Ramiro continue to be at the forefront in ensuring that unscrupulous businessmen would not take advantage of the situation by selling overpriced personal protective equipment (PPE) and medical supplies. Further, there is an ongoing case build-up by BOC-IG Team Leader IO3 Alvin Y. Enciso, National Bureau of Investigation (NBI) and Department of Trade and Industry (DTI) to pin down personalities illegally selling medicines which can allegedly cure COVID-19 infection.

In its operations, the BOC-IG team leader Alvin Enciso has been continuously coordinating with concerned agencies such as the Philippine Coast Guard (PCG), DTI and NBI in investigating traders selling medicines claiming to cure COVID 19, yet without Food and Drug Administration (FDA) permit. BOC-IG reported that they have been closely monitoring situation at the various ports and validating reports of smuggled PPEs and medical supplies that are of great demand at this time of pandemic.

In coordination with counterparts from the NBI, DTI and PCG, the BOC has been keeping its ears close to the ground and

validating with reliable sources for possible leads on illegal selling of essential health supplies and medicines. In a span of 1 week, from March 25 to March 31, the BOC-IG raided three medical supply stores in Manila and confiscated an estimated Php 20 million worth of PPE and medical supplies such as facemasks, gloves, goggles, and other medical items including alcohols, thermal scanners, test tubes, and syringes. Currently there is already an ongoing forfeiture proceeding against the three establishments before the BOC's Law Division, with the owners facing possible criminal charges before the courts.

BOC NAIIA condemns 2 tons of unsafe medicines and meat products!

THE Bureau of Customs [BOC-NAIA] condemned 2 tons of seized medicines and meat products at Trece Martires, Cavite on May 22, 2020.

Some of the shipments that were condemned are unregistered medicines with an estimated weight of 350 kilos. These medicines were seized for failure to obtain necessary clearance from the Food and Drug Administration (FDA) and thus unsafe for human consumption.

The condemnation of the unregistered medicines is part of Bureau of Customs border protection initiatives to protect the public against unsafe medicines.

Along with the medicines are expired food stuff and meat products with no health clearance.

The said unsafe goods were condemned using the Thelmal Decomposer (Pyrolysis) Facility of the Integrated Waste Management Inc. located in Trece Martires City.

The thermal decomposer will ensure the safety and no single waste item will find its way to the market.

The condemnation was coordinated with Food and Drug Administration (FDA), Department of Agriculture (DA), Bureau of Animal Industry (BAI), Bureau of Fisheries and Aquatic Resources (BFAR), and Commission on Audit (CoA).

This is in compliance with Commissioner Rey Leonardo Guerrero's directives to continue to protect the country against entry of illegal goods and importations that are not compliant to Customs regulations.

The BOC assures the public that it will continue to provide government service 24/7 to protect the country's border.

POM Seizes P34.7-M worth of Misdeclared Cigarettes!

THE Bureau of Customs-Port of Manila (BOC-POM) seized on May 8, 2020 Php 34.7 million worth of Two Moon brand cigarettes misdeclared as furnitures and blinds contained in two (2) containers. The containers were alerted after POM received a derogatory information from the BOC-Enforcement Group (EG).

The shipments from China arrived last April 27 and May 1, 2020 and were consigned to Vierport International Co. and Anikas Will Industry Corp. which were put on hold a day after arrival dates and were examined on Friday, May 8, 2020. The BOC-POM conducted 100% physical examination of the containers together with the Philippine Drug Enforcement Agency (PDEA).

District Collector Arsenia Ilagan ordered the issuance of Warrants of Seizure and Detention against the subject shipment for violation of Section 1400 "Misdeclaration, Misclassification and Undervaluation in Goods Declaration" in relation to Section 1113 "Property Subject Seizure and Forfeiture" of the Customs Modernization and Tariff Act [CMTA]. The BOC-Port of Manila will continue to be vigilant against customs fraud and fulfil its mandate to strengthen border security.

BOC Commended by Misamis Oriental Rep. Uy for Ongoing Efforts in Re-Exporting Verde Soko Waste Despite ECQ!

THE Misamis Oriental 2nd District Representative Juliette T. Uy recently lauded the Bureau of Customs [BOC] under the stewardship of Customs Commissioner Rey Leonardo B. Guerrero for the continuous processing of the remaining 2,500 MT of Verde Soko waste to be re-exported to South Korea despite delays brought about by the COVID-19 pandemic.

Congresswoman Uy, as the Principal Author of the House Bill 3461 or the Total Ban on Import and Export of Wastes Act, issued a letter of gratitude thanking Customs Commissioner Rey Leonardo B. Guerrero and the Department of Finance Secretary Carlos Dominguez III for commitment in re-exporting the wastes.

The re-exportation of the remaining 2,500 MT of wastes is currently being delayed by restrictions due to the on-going health crisis and the difficulties of re-bagging the said wastes already exposed to natural elements. The Commissioner however, assured that the Bureau, through the Collection District of Cagayan de Oro [CDO] Concurrent headed by District Collector John Simon, will undertake all the necessary means in accordance with the law to expedite the re-exportation of the wastes to South Korea.

The Solon ended her letter by vowing to continue working with the BOC in bringing the Verde Soko case to its proper conclusion through the prosecution of all persons and organizations involved in the matter.

Marks 7.7 Billion Liters of Fuel Since Start of Fuel Marking Program!

The Bureau of Customs [BOC] under the stewardship of Customs Commissioner Rey Leonardo B. Guerrero marked 135,441,776 liters of fuel during the period of quarantine restrictions, which manifests its unrelenting effort in implementing the fuel marking program and collecting the proper revenue that is essentially needed to support various assistance programs by the Government in this time of crisis. Participated in by 20 petroleum companies, the Bureau of Customs and Bureau of Internal Revenue marked 7,705,434,076 liters of fuel nationwide from September 2019 up to May 21, 2020. Of the total volume of marked fuel, Luzon accounted for 76% while Mindanao accounted for 20% and Visayas for 4%.

Spearheaded by the Department of Finance, Bureau of Customs and Bureau of Internal Revenue, the Fuel Marking Program

was officially launched on August 2019 with the intention of putting a halt to illegal importation, manufacturing and other fraudulent activities relating to the use and sale of petroleum products in the country.

With the Program, marking of refined, manufactured, and imported gasoline, diesel and kerosene including those withdrawn from freeport zones to be used in the domestic market has become mandatory.

Zambo Coll. Barte Seizes Smuggled Cigarettes and Cigarette-Making Machines!

The Zamboanga Peninsula Inter-Agency Anti-Smuggling team continues to score big against fake cigarette smugglers and manufacturers in the region. A sequel to the previous raids in the region yielded another P14 million worth of fake and imported cigarettes and P100 million worth of materials for manufacturing of cigarettes. The previous raids on similar items resulted in the confiscation of cigarettes and machines for the manufacture of fake cigarettes.

The Zamboanga Peninsula inter-agency team is composed of the Bureau of Customs, NBI IX, PNP Regional Office IX, Westmincom, PCG and BIR. The Port of Zamboanga Acting District Collector Sigmundfreud Z Barte Jr commended the inter agency anti-smuggling team for a job well done.

He also echoed the constant reminder and the strict order of Commissioner Rey Leonardo B Guerrero to help protect the border and intensify anti-smuggling operations in order to collect more rightful duties and taxes due to the government. Coll. Barte stressed the need for an inter-agency approach in order to fight smuggling in the region. The success of the anti-smuggling operations is also attributed to the help of the AFP and PCG in patrolling the seas and manning the check points.

ESS intercepts fake cigarettes, raw tobacco materials, cigarette-machines worth P1.3 billion!

THE operatives of the Bureau of Customs [BOC]-Enforcement and Security Service (ESS) intercepted on May 28, 2020 various assorted fake cigarettes, raw tobacco materials and cigarette packing machines with an estimated value of P1.3 billion. Armed with Letter of Authority issued by the BOC, ESS agents inspected on May 28, 2020 a warehouse said to contain fake cigarettes at Brgy. Palattao, Naguilian, Isabela.

The initial inventory showed that there are roughly 2,000 master cases of assorted cigarettes; 10 units of cigarette-making machines, 12 units of cigarette packing machines and 300 boxes of tobacco raw materials stored inside the subject warehouse. The said goods were immediately intercepted by Customs for lack of permit and violation of Customs laws, rules and regulations. The operation was coordinated with the officials of the Barangay Palattao, the Philippine National Police (PNP) Isabela Police Provincial Office, and the Bureau of Internal Revenue (BIR) who were also present during the inspection. P10.1 Million Worth of Smuggled Cigarettes Seized in Zamboanga City!

A joint team led by the BOC-Port of Zamboanga District Collector Segundo Sigmundfreud Z. Barte JR, together with elements of Zamboanga City Police Station 8 and Joint Task Force Zamboanga intercepted 300 cases of assorted cigarettes bearing the brands Gundang Baru, Cannon White, Famous, Canyon, Berlin and Fort cigarettes at Istanbak, Brgy. Lower Calarian, Zamboanga City on May 26, 2020.

Accordingly, the smuggled cigarettes with an estimated value of P10,125,000.00 most likely came from Malaysia or Indonesia and will be distributed in ZAMBASULTA area. The operation stemmed from the information received that certain individuals are engaged in cigarette smuggling at Lower Calarian near the Petron Depot. The intensified anti-smuggling efforts in ports nationwide is part of the marching order of Customs Commissioner Rey Leonardo B. Guerrero. The seized cigarettes were turned-over to BOC-Zamboanga for issuance of Warrant of Seizure and Detention for violation of Executive Order No. 245 titled Amended Rules and Regulations Governing the Exportation and Importation of Leaf Tobacco and Tobacco Products and Section 117 of RA 10863 otherwise known as Customs Modernization and Tariff Act [CMTA].

operations. Authorities believe that the company is hoarding and overpricing medical supplies and equipment such as high-pressure stream sterilizer, blood bags, books, real-time quantitative thermal cyclers, and other medical supplies and equipment.

Commissioner Rey Leonardo B. Guerrero issued the Letter of Authority and Mission Order after the televised address of President Rodrigo Duterte on Tuesday. The President directed the National Bureau of Investigation (NBI) and other officials to go against individuals and entities taking advantage of the pandemic by hoarding and overpricing medical supplies and equipment. "These companies are profiting from this pandemic by hoarding and selling these items for a higher price than what their true value are in the market. The agency is investigating all sellers of these overpriced medical supplies. We are not done yet," Com. Guerrero warned. Omnibus, which claims to be the exclusive distributor of

No other IDs or passes specifically exempting persons from community quarantine shall be required of workers of permitted establishments and/or offices without prejudice to requiring the presentation of other documents establishing the nature of their work.

The bureau will file a case against the company if they fail to show proof of payment of taxes and duties.

"This is a clear message to all sellers hoarding and overpricing these much-needed medical supplies. The bureau is going to come after you. The President made it clear that we will not be tolerant of companies who are taking advantage of this pandemic," said DepCom. Ramiro.

This isn't the first time the BOC-CIIS raided a store or warehouse selling overpriced medical supplies. In March and April, the agency seized some P50 million worth of Personal Protective Equipment (PPE) and alcohol from different stores in Manila. A similar raid was done in a warehouse located in Singalong, Malate, Manila for selling alleged medicines against COVID-19 worth P40 million earlier this month. Under R.A Act 7581 or the Price Act and R.A 11469 or The Bayanihan to Heal As One Act, Profiteering or earning large and unfair profits, especially in this time of emergency is punishable by Law.

Kaya ang Ibig sabihin ang 18M umano na benepisyaryo ay binubuo ng 82% kung saan ang iba sa mga ito ay nasa middle class.

Igiiit po senadora sa hearing ng Senate Committee of the Whole na kung ang datos ng DSWD ay batay sa 2015 census, tanging 60% lang ng total population ang makakatanggap ng government assistance.

Ipinahayag ni National Economic and Development Authority (NEDA) acting secretary Karl Kendrick Chua na nabuo umano nila ang 18M para maging "accurate" dahil tumaas ang

komunidad.

Ang mga dayuhang nasyonalidad ay maaaring umalis sa Pilipinas anumang oras, habang ang mga manggagawang Pilipino lamang sa ibang bansa, at permanenteng residente o may hawak ng mga visa ng mag-aaral sa kanilang bansang pupuntahan ang maaaring pagagan na umalis.

"Ang pagdating at pag-alis ng mga komersyal na flight ng pasahero na patuloy na nagpapatakbo ay maaaring magdala lamang ng mga na-exempt mula sa pagbabawal.

Sabi ni Morente. Hinikayat niya ang mga netizen na itigil ang pagpopost ng mga pekeng balita at "suriin at dobleng suriin ang impormasyon sa online, at palaging i-verify sa pamamagitan ng mga lehitimong mapagkukunan".

Sisimulan ng Department of Public Works and Highways (DPWH) ang pagtatayo ng mga pansamantalang dormitoryo para sa mga manggagawa sa pangangalagang pangkalusugan simula sa unang linggo ng Hunyo sa Quezon Memorial Circle sa Quezon City.

Sinabi ni Dpwh Sec. Mark Villar na ang iminungkahing 'We Heal as One Offsite Dormitory' ng DPWH Task Force upang Mapadali ang Augmentation ng Lokal ng Pambansang Kalusugan na Pasilidad sa Quezon Memorial Circle ay isang kinakailangang pasilidad para sa mga manggagawa sa pangangalagang pangkalusugan na ma-recharge ang isip at katawan ng tao pagkatapos ng isang mahigpit na araw sa mga frontlines ng COVID-19.

Sa kanyang ulat kay Kalihim Villar, sinabi ni Undersecretary Emil K. Sadain na ang pagsusuri sa mga iminungkahing aktwal na lugar ng nakaplanong anim (6) na offsite dormitoryo sa Quezon Memorial Circle ay isinasagawa ng DPWH Task Force upang Mapabilis ang Augmentation of Health Facility na kasama ang mga kinatawan mula sa lokal na pamahalaan ng Quezon City.

Sinabi ni Undersecretary Sadain na ang mga offsite dormitoryo para sa mga medikal ay inilang para sa mga medikal populasyon mula 2015 hanggang 2020.

Ang pagbili daw ng gobyerno ng mas mahal na medical equipment sa gitna ng coronavirus disease pandemic depensa ni Health Secretary Francisco Duque III.

Si Senator Panfilo Lacson ang siyang nakapuna sa umano'y "grossly overpriced" na mga health at medical supplies na binili ng gobyerno para sa Department of Health (DOH).

Kaagad na ipinasa ni Duque ang mga katanungan ng mga senador kay Budget Undersecretary Lloyd Lao, executive director of the Procurement Service, at sinabing wala sa mga items ang direktang binili ng DOH da pagdinig ng Senate committee of the whole kaugnaay sa updates sa COVID-19 response.

At dito nga ay hiniling nila ang tulong ng PS-DBM o Procurement Service of the Department of Budget and Management, dahil sa panahong iyon umano ay nagsisimula silang pataasin at habulin ang testing capacity.

Nagpahayag ng paniniwala si Duque na umano silang ang PS-DBM ang may mas malawak na network ng local at international suppliers kung kaya naisip daw nilang makakakuha sila ng mas competitive kung hindi man reasonable pricing points. Samantala makikialam na daw ang Palasyo sa problema ng maraming overseas Filipino workers (OFWs) na patuloy na nakatengga sa maraming quarantine hotels, facilities and vessels sa bansa.

Bagamat nasa hurisdiksiyon ng Overseas Workers Welfare Administration (OWWA) ang pag-aasikaso sa concern na ito ng mga OFWs, pakikialaman na ito ng Malacañang dahil mismong si Pangulong Rodrigo Duterte ay nababahala na rito ayon kay Presidential Spokesman Harry Roque.

At gusto na ring malaman ng Malacañang kung ano ang ugat ng reklamo ng mga OFWs na kasama yata sa reklamo ng mga OFWs, naisailalim na sila sa rapid test at polymerase chain reaction (PCR) tests at marami na rin sa kanila ang nabigyan ng certification ng Bureau of Quarantine pero hanggang ngayon ay hindi pa rin sila pinapayagang makauwi sa kani-kanilang pamilya.

At hihingin na niya sa OWWA ang imbentaryo ng mga OFWs na naisailalim sa rapid test at PCR test at sino-sino ang mga may resulta na para ang mga negatibo naman sa test ay agad nang mapauwi dagdag ni Roque.

But as mayor, it is my responsibility to ensure that we should focus on our real enemy which is COVID-19," ani Mayor Emi.

Sinabi ni Mayor Rubiano, nakipag-usap at nagtanung-tanong na rin sa mga sangkot sa pangyayari upang kunin at pakinggan ang kanilang panig kaya naniniwala siya na may misunderstanding lang kaya nangyari iyon. Napag-alaman na may ipinalabas noong isang linggo ng Memorandum ang Pasay City Human Resource Management and Development Office noong Mayo 18, 2020 kaugnay sa COVID-19 Rapid Testing.

"In line with the City's policy to ensure the safety of its employees and workplace, please be informed that there will be a rapid testing for the skeleton workforce starting tomorrow 19 May 2020 at the Sangguniang Panglungsod Session Hall..."

Gayunman, hindi nagustuhan ng konsehal na sa session hall idaos ang rapid testing dahil madalas umano idis-infect ang session hall at delikado na doon pa magkalat sakaling may virus. Sa

na tauhan ng East Avenue Medical Center, Philippine Heart Center, Lung Center of the Philippines, National Kidney and Transplant Institute, Veterans Memorial Medical Center, V. Luna Medical Center at iba pang ospital mga manggagawa.

Sinabi ni Usec Sadain habang ang DPWH ay nag-ambag sa pambansang pagsisikap ng gobyerno sa pagbuo ng mga pasilidad sa quarantine sa pamamagitan ng pag-converge ng mga pampublikong gusali at puwang sa COVID-19 na 'Heal as One Center' para sa pagkahiwalay at paggamot ng mga pasyente, mahalaga din na bigyan ng mataas na prioridad sa pagtugon sa pangangailangan para sa mga pasilidad ng tirahan ng mga tauhang medikal upang matiyak ang kanilang kaligtasan at kahusayan sa paghahatid ng kanilang mga serbisyo sa kalusugan.

Sa mga tagubilin ni Kalihim Villar, ang DPWH Task Force na pinamumunuan ni Undersecretary Sadain ay paunang ipinakita at tinalakay kay Quezon City Mayor Joy Belmonte ang konsepto at naghanda ng mga plano para sa pagtatakda ng mga binuo na mga dormitoryo na binuo upang pansamantalang magbahay ang mga medikal na doktor at ospital at mga tauhan.

Nagpahayag ng buong suporta ang Lungsod sa inisyatibo ng DPWH ng pagbuo ng mga off-site na dormitoryo sa Quezon Memorial Circle na malapit sa mga pangunahing ospital sa Quezon City na nakikipag-away sa laban sa COVID-19.

Batay sa mga plano ng disenyo na inihanda ng DPWH Task Force, ang isang one-story dormitoryo ay maaaring magkaroon ng 16 na silid na may magkahiwalay na banyo sa pamamagitan ng pagsasama-sama ng dalawang 40-paa na modular na lalagyan sa kaliwa at kanang panig na may gitnang puwang para sa karanawang kainan at hiwalay na puwang para sa labahan at kusina na lugar sa dulo.

Ang isang (1) dormitoryong nasa labas na site ay maaaring makaipon ng 32 mga medikal na tauhan na maiiwasan mula sa paglalakbay mula sa ospital patungo sa bahay para sa isang maikling pahinga.

Ayon pa kay Sadain kapag hindi na kinakailangan ang pansamantalang dormitoryo ay maaring mai-disassemble at ang bawat isa na maiimbak ng Dpwh para sa iba pang mga kaugnay na kinakailangan tulad ng pansamantalang kanlungan sa panahon ng pagtugon sa kalamidad.

Kung talagang hindi umano mapanganib, bakit naglagay pa ng mga plastic na harang at nakasuot pa ng personal protective equipment (PPE) ang mga nagsagawa ng rapid testing.

SAMANTALA nasa may 40,000 eligible Parañaque residents ang tatanggap ng tig P5,000 cash assistance mula sa lokal na pamahalaan sa ilalim ng new Parañaque-Cash program sa pagpasok ng Hunyo. Inihayag ni Mayor Edwin Olivarez.

Ayon sa alkalde, kabilang sa magbebenipisyo sa programang ito ang mga "left-out households" na hindi man lang nakatanggap ng kahit anong cash assistance mula sa national government sa ilalim ng Social Amelioration Program (SAP), expanded 4Ps, at COVID-19 Adjustment Measures Program ng Department of Labor and Employment (DOLE).

"Households who did not receive cash from the national government are entitled to P5,000 cash assistance as part of the city's relief efforts to mitigate the economic impact caused by coronavirus disease 2019 (COVID-19) pandemic," ani Olivarez.

Ang pondo sa Parañaque-Cash program ay nagmula sa sinuspondeng konstruksiyon ng P200 million astrodome project na dapat sanang makumpleto ngayong taon.

Batay kay Mar Jimenez, hepe ng Public Information Office (PIO) ang eligible households ay kailangang mag fill-up ng intake form na ido-download mula sa computer sa pamamagitan ng kinatawan na nasa hustong gulang na. Ilalaki ng aplikante ang sertipikasyon na siya o ang mga kasama sa bahay ay hindi pa nakatanggap o targeted beneficiary ng SAP.

Matapos ang maikling interview bago siya bigyan ng "Europay, Mastercard, at Visa" card (EMV) o alimang debit card kung saan idadaan ang Parañaque-cash pay-out. Ang EMV card ay ipapangalan sa household's designated representative.

"The distribution scheme may be carried out by house-to-house, sitio-by-sitio, or plaza type depending on population density and size of the area, with strict adherence to stringent social distancing measures," ani Jimenez. Nilinaw pa ni Jimenez na ang intake form ay isang public document kaya dapat na totoong impormasyon ang isusulat upang hindi makasuhan.

Kapag may nakitang pagsisinuugaling sa form, magiging ground ito para ma-black list ang aplikante o sinumang miyembro ng isang household para sa anumang uri ng relief assistance.

SA KABILANG dako naman nabatid na pinag-aaralan rin ng gobyerno ang "zone" o barangay lockdown at ayon nga kay Defense Secretary Delfin Lorenzana na posibleng isailalim ang Metro Manila sa General Community Quarantine (GCQ) sa June 1.

Hindi agad-agad magpapatupad ang gobyerno na lubusang tanggalin ang lockdown, sa kabila na ang mga kaso ng COVID-19 ay nag-lelevel off na, sa layuning maipatupad sa mga tao ang sariling disiplinang ayon kay Lorenzana. Ito ay bilang paghahanda para sa mga residente sa Kamaynilaan sa "new normal," kung saan uugaliin na ang pagsusuot ng face mask, maging ang iba pang health at safety protocols sa loob rin ng mga opisina.

Sa kasalukuyan ay tinutukoy pa Inter Agency Task Force (IATF) ang mga lugar sa Metro Manila na may mataas na kaso ng infections.

LGUs ASK TO SUPPORT FISHERFOLKS/FISH TRADERS AFFECTED BY COVID19

The Bureau of Fisheries and Aquatic Resources (BFAR) in Central Visayas has urged local government units (LGUs) to support fishermen and fish traders that are currently affected by Covid19 pandemic.

BFAR-7 Regional Director Allan Poquita said " Fewer people are allowed to go out of their houses to buy necessities and commodities. Some traders could hardly pass through border's because of the Enhanced Community Quarantine (ECQ). We fully support the measures imposed by the LGUs but we are also asking their help to address the plight of our fishery stakeholders."

He insisted that the fishery industry has been crippled by the pandemic following impositions of travel and people movement restrictions.

As he is asking local officials to allow fish dealers and traders to have access in going into and out from the fishing landing centers in the region.

There are two known fishing landing centers in Metro Cebu and these are: Barangay Pasil in Cebu City and the fishport in Danao City.

On BFAR's part, they have been issuing food passes to suppliers and truckers to grant them privilege to get through checkpoints so that there will be unhampered movement of cargoes, fishery inputs, and any other food products.

Fisherfolks and fish traders complained on the slowdown of sales as there maybe sufficient fish supply but only a few dealers or customers get to buy their products.

Since some fishes are perishable, some vendors are forced to sell their products at very low prices just so they can dispose them at good quality.

While some buyers from other provinces or towns could not travel or get through borders because of the restricted movement and banned sea trips.

Poquita encourages LGUs through Municipal Agriculture Office (MAO) to facilitate transport of fish products for the landing centers to their fish markets to ensure availability of fish commodities in their area as local officials may even offer the fish products available in their market as goods to be given to households.

BFAR-7 proposes in putting up of mini- fish markets which should be accessible to assist marginal fishermen sell their fish catch.

DOST-RO2 boosts assistance to Isabela farmers with 20 units of Multi-Purpose Solar Drying trays

TUGUEGARAO CITY- Over 120 Isabela farmers in the Cagayan Valley region look forward to improving the quality of their produce after the Department of Science and Technology Region 02 (DOST-RO2) office provided six of their agricultural cooperatives 20 units of Multi-Purpose Solar Drying Trays. The equipment were given free.

The six farmers cooperatives include the Nakar Agriculture Cooperative, IP Agricultural Credit Cooperative, Dimas Agriculture Cooperative, Jones Goat Raiser Agriculture Cooperative, and the Dibulan Farmers Organization. All six are in the fourth district of Isabela province. The last two are based in Jones, Isabela.

POLITICS CONTINUE TO HOUND RELIEF GOODS/ QUARANTINE PASSES DISTRIBUTION IN CEBU CITY.

"Politics should not play a role in this very important chapter in our lives karon(now), we are facing a very terrible crisis," said Cebu City Mayor Edgardo Labella.

However, his statement is not being followed by his appointed job order employees from the Mayor's Information and Liaison Office (MILO) in the 80 barangays in the city.

This as DAILY TRIBUNE continue to receive complaints that these MILO officers have been selecting families/individuals to benefit from the relief goods and quarantine passes (QP).

In more than 50 barangays in the city which are identified with Bando Osmena-Pundok Kauswagan (BOPK), a local political party organized by former Mayor Tomas Osmena, the MILO took over the barangay functions in determining who are qualified to benefit from the rice allocations and QPs.

The city government purchased 100,000 sacks of rice for distribution to 120,000 families.

But MILO operatives insisted on having their own list of beneficiaries setting aside existing barangay survey data. Labella in a text message to DAILY TRIBUNE admitted " that is my big problem, they (MILO) still play politics." But he refused to suspend MILO operations as advised by his political allies.

Osmena on the other hand in a text message said " Labella is aware of the problem and REFUSES to act which is the REAL PROBLEM. And he expects your understanding? "

The former mayor added " Labella will not move even its poor peoples food and not just money thats being stolen."

He reminded Cebuanos that during the super typhoon Ruping in the early 1990's, there was no politics and the City and Province of Cebu then succeeded in restoring back Cebu.

"There was no confusion and poitics during Bagyong Ruping. 100% blackout, no water, thousands of garbage, 5 landslides, blocked roads, no radio, TV and newspaper and we survived smoothly with no chaos like today. Instead we had operation Asphalt Storm and 2,000 sodium lights replaced old ones. All these in over a month."

Labella when asked by media on advices to suspend MILO operations, he said this will coordinate with barangay officials especially the barangay captains.

He even denied knowing the MILO officers as being tasked to distribute QPs and relief goods.
